

Senate Bill 559

Sponsored by Senator EDWARDS; Senators BATES, BEYER, DEVLIN, KRUSE, Representatives BARNHART, BEYER, HARKER, HOLVEY, HOYLE, NATHANSON (at the request of University of Oregon Foundation) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes University of Oregon as independent public university, governed by University of Oregon Board of Directors.

Empowers State Board of Higher Education to adopt performance benchmarks to be achieved by University of Oregon. Exempts university from certain laws and future amendments to certain existing laws. Allows university to obtain insurance, adopt alternative employee benefit plans and offer alternative retirement programs. Requires university to adhere to existing collective bargaining agreements unless modifications are collectively bargained, and to collectively bargain employee benefit and retirement plans. Allows university to issue revenue bonds and enter into credit enhancement agreements and financing agreements. Allows university to sue and be sued, make all necessary or convenient contracts and do any other act in relation to university property and matters of university concern.

Declares emergency, effective July 1, 2011.

Be It Enacted by the People of the State of Oregon:

SECTION 1. As used in sections 1 to 52 of this 2011 Act:

(1) "Board" means the University of Oregon Board of Directors established under section 4 of this 2011 Act.

(2) "Public university" means a body politic and corporate that is created by the state to carry out public missions and services relating to education, culture, research, the development, enhancement and dissemination of information, economic and business development and other matters beneficial to this state. A "public university" is a state institution of higher education, but is not an agency, department or division of the state or part of the executive branch except as set forth in sections 1 to 52 of this 2011 Act.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (3) “University” means the University of Oregon public university established under sec-
2 tion 2 of this 2011 Act.

3 **SECTION 2.** (1) The University of Oregon is established as a public university and shall
4 be governed by the University of Oregon Board of Directors. The board may exercise au-
5 thority over matters of university concern to the fullest extent allowed by Constitutions and
6 laws of the United States and this state, as fully as if each particular power comprised in
7 that general authority were specifically listed in sections 1 to 52 of this 2011 Act. The board
8 may delegate and provide for the further delegation of any of its powers and authorities.

9 (2) The powers granted by this section are in addition to any other grants of power to
10 the University of Oregon in sections 1 to 52 of this 2011 Act and may not be construed to
11 limit or qualify any such grant. The powers granted by this section shall be liberally con-
12 strued to the end that the board shall have all powers over matters of university concern
13 that is possible for it to have under the Constitutions and laws of the United States and this
14 state.

15 (3) The university is an instrumentality of state government, performing governmental
16 functions and exercising governmental powers. The university is independent, has statewide
17 purposes and is without territorial boundaries. The university is a state institution of higher
18 education, but is not an agency, department or division of the state, a unit of local or mu-
19 nicipal government or part of the executive branch except as set forth in sections 1 to 52 of
20 this 2011 Act.

21 (4) Nothing in sections 1 to 52 of this 2011 Act may be construed as a waiver by the
22 university of any form of defense or immunity, whether it be sovereign immunity, govern-
23 mental immunity, immunity based upon the Eleventh Amendment to the Constitution of the
24 United States or immunity from any claim or from the jurisdiction of any court.

25 (5) The Legislative Assembly intends that sections 1 to 52 of this 2011 Act serve as the
26 model for the creation of public universities in addition to the University of Oregon at such
27 time as other institutions of higher education currently under the jurisdiction of the State
28 Board of Higher Education may desire to become independent public universities and request
29 the Legislative Assembly to create them as such.

30 **SECTION 3.** (1) It shall be the policy of the University of Oregon as a public university:

31 (a) To serve the people of this state by educating citizens of the state, region, nation and
32 world;

33 (b) To provide:

34 (A) An educational environment that stimulates creative inquiry, critical thinking, clear
35 communication and original scholarship by and for the benefit of students, faculty, staff and
36 the greater community; and

37 (B) Education, research and service that contribute to the development of new knowledge
38 and the enhancement of the culture and economy of this state;

39 (c) To encourage the preservation, enhancement and dissemination of knowledge and
40 culture;

41 (d) To provide individuals with the tools for a lifetime of learning so as to allow them to
42 enhance their quality of life, contribute to civic discourse and civil society and participate
43 effectively in a global society;

44 (e) To create an educated workforce that keeps the Oregon economy innovative and
45 competitive;

1 (f) To provide public service activities that engage the professional expertise of faculty
2 to solve society's problems;

3 (g) To share with the state many services and cultural activities of immense importance
4 to the quality of life enjoyed by Oregonians and others; and

5 (h) To strive for excellence in all of its endeavors while maintaining institutional integ-
6 rity.

7 (2) The university shall carry out the policies of this section in the manner that, in the
8 determination of the University of Oregon Board of Directors, best promotes the welfare of
9 the people of this state.

10 **SECTION 4.** (1) There is established a University of Oregon Board of Directors, consist-
11 ing of 15 members.

12 (2) The membership of the board shall be as follows:

13 (a) Seven members appointed by the Governor and confirmed by the Senate in the man-
14 ner prescribed in ORS 171.562 and 171.565. These members shall include one student enrolled
15 at the University of Oregon and one University of Oregon faculty member.

16 (b) One member who is a nonstudent member of the State Board of Higher Education,
17 appointed by the State Board of Higher Education.

18 (c) One member who is a member of the University of Oregon Foundation Board of
19 Trustees, appointed by the University of Oregon Board of Directors in consultation with the
20 foundation board of trustees.

21 (d) Five members appointed by the University of Oregon Board of Directors.

22 (e) The president of the university, who shall be a nonvoting member.

23 (3) The board may appoint other nonvoting members as it deems in the best interests
24 of the university.

25 (4)(a) Except for the president of the university, the term of office of each nonstudent
26 member is four years. The term of office of the student member is two years.

27 (b) Before the expiration of the term of a member, the appointing authority shall appoint
28 a successor whose term begins on July 1 next following. A member is eligible for reappoint-
29 ment for one additional term.

30 (c) If there is a vacancy for any cause, the appointing authority shall make an appoint-
31 ment to become effective for the remainder of the unexpired term. For members appointed
32 by the Governor, the board shall nominate a slate of candidates whenever a vacancy occurs
33 or is announced and shall forward the names of the recommended candidates to the Gover-
34 nor for consideration.

35 (d) A student of the university may not be appointed to, or continue to serve on, the
36 board unless the student is in good standing pursuant to bylaws or policies of the board.

37 (5) Except as provided in subsection (2)(a) of this section, a voting member may not be
38 an employee of the university, the state of Oregon or the Oregon University System.

39 (6) The board shall select one of its members as the chairperson, another as vice chair-
40 person and another as secretary, for such terms and with such duties and powers as the
41 board considers necessary for performance of the functions of those offices. The board shall
42 adopt bylaws for its governance, including provisions specifying how a quorum is constituted
43 and when a quorum is necessary.

44 (7) The board shall meet at least once every three months on the university campus.
45 Board members may participate in the meeting electronically as provided in ORS 192.610 to

1 **192.690. The board shall meet at such other times and places specified by the chairperson or**
 2 **by a majority of the members of the board.**

3 **(8) An appointing authority may remove any member appointed by the authority at any**
 4 **time for cause, after notice and public hearing.**

5 **SECTION 5. Notwithstanding the terms of office specified in section 4 of this 2011 Act,**
 6 **of the members first appointed to the University of Oregon Board of Directors, other than**
 7 **the president of the University of Oregon:**

8 **(1) Four members appointed by the Governor, including the student member, and three**
 9 **members appointed by the board shall serve for terms ending June 30, 2013; and**

10 **(2) Three members appointed by the Governor, including the faculty member, two mem-**
 11 **bers appointed by the University of Oregon Board of Directors, the member appointed by the**
 12 **State Board of Higher Education and the member appointed in consultation with the Uni-**
 13 **versity of Oregon Foundation Board of Trustees shall serve for terms ending June 30, 2015.**

14 **SECTION 6. The Governor and the State Board of Higher Education shall appoint mem-**
 15 **bers to the University of Oregon Board of Directors no later than 60 days after the effective**
 16 **date of this 2011 Act. These board members shall appoint the remaining board members no**
 17 **later than 60 days after confirmation of the gubernatorial appointees by the Senate.**

18 **SECTION 7. (1) The University of Oregon Board of Directors may, within or outside the**
 19 **state, do all things necessary or convenient involving matters of concern to the University**
 20 **of Oregon, including without limitation the following:**

21 **(a) Enact any and all policies for the governance of the university, which, to the extent**
 22 **set forth in those policies, shall have the force of law and may be enforced through univer-**
 23 **sity procedures and in any court of competent jurisdiction.**

24 **(b) Hire and employ personnel and prescribe all conditions of employment, including but**
 25 **not limited to compensation, benefits and tenure.**

26 **(c) Enter into any and all contracts and agreements with any public or private entity.**

27 **(d) Enter into any partnership, joint venture or other business arrangement and create**
 28 **and participate fully in the operation of any business structure or organization.**

29 **(e) Borrow money and issue debt of any kind and pledge revenue to repay any loan or**
 30 **indebtedness.**

31 **(f) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-**
 32 **trol, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, issue, im-**
 33 **prove, develop, use, expend and dispose of personal property, including intellectual property,**
 34 **of any nature, tangible or intangible.**

35 **(g) Acquire, purchase, purchase on a contractual basis, borrow, receive, own, hold, con-**
 36 **trol, convey, sell, manage, operate, lease, lease-purchase, license, lend, invest in, improve,**
 37 **develop, use, expend and dispose of real property.**

38 **(h) Sue and be sued and issue and enforce subpoenas in the board's name.**

39 **(i) Obtain and receive gifts, bequests and donations for the benefit of the university and,**
 40 **subject to the terms of the gift, retain, invest and use such gifts as deemed appropriate by**
 41 **the university or the board. The board may assess a reasonable management fee against all**
 42 **gifts, bequests and donations and the earnings thereon.**

43 **(j) Acquire, purchase, accept, borrow, receive, own, hold, deposit, pledge, control, convey,**
 44 **manage, use, lend, expend and invest all funds, appropriations, instruments, earnings and**
 45 **revenue. The authority under this paragraph includes accepting and expending funds from**

1 the United States Government for any purpose. The board may deposit any and all funds,
 2 appropriations, instruments, earnings and revenue in any financial institution and retain all
 3 interest, earnings, and appreciation accruing from such deposits.

4 (k) Erect, construct, improve, remodel, develop, repair, maintain, equip, furnish, lease,
 5 lend, convey, sell, manage, operate, use and dispose of any building, structure, land or
 6 project.

7 (L) Acquire any and all insurance, operate a self-insurance program or otherwise arrange
 8 for the equivalent of insurance coverage of any nature or type.

9 (m) Create, develop, manage and control educational, research, service and any other
 10 programs.

11 (n) Set standards for the admission, graduation and discipline of students.

12 (o) Authorize, establish, eliminate, manage, operate, reorganize, reduce or expand any
 13 program, school, institute, college or unit of operation.

14 (p) Authorize, establish, eliminate, charge, collect, manage, use in any manner and ex-
 15 pend all revenue derived from tuition, fees and any other charges and fines. The board shall
 16 request the joint recommendation of the recognized student government and the president
 17 of the university, who shall obtain the recommendation of the recognized student govern-
 18 ment, prior to authorizing, establishing or eliminating incidental fees for programs under the
 19 supervision or control of the board and found by the board to be advantageous to the cultural
 20 or physical development of students.

21 (q) Acquire, receive, own, hold, use, sell, mortgage, lend, pledge, invest in or otherwise
 22 dispose of and deal in or with the shares, stock, bonds, or other equity or interests in or
 23 obligations of any entity.

24 (r) Make available and perform any and all services on such terms as considered appro-
 25 priate.

26 (s) Delegate any and all powers and duties and provide for any further delegation.

27 (t) Provide and disseminate to the public information relating to the program, operation
 28 and finances of the university.

29 (u) Exercise any other power, duty or responsibility necessary or convenient over mat-
 30 ters of university concern.

31 (2) The absence of express authority may not be construed to deny that authority to the
 32 university or to limit or qualify any such power. Powers of the board shall be liberally con-
 33 strued to effect the purposes of the university.

34 **SECTION 8.** The University of Oregon Board of Directors shall appoint a president of the
 35 University of Oregon. The president is the president of the faculty and is the chief executive
 36 officer of the university. The president has authority to direct the affairs and operation of
 37 the university, subject to the policies of the board.

38 **SECTION 9.** (1) Notwithstanding subsection (5) of this section, the provisions of ORS
 39 30.260 to 30.460, 200.005 to 200.025, 200.045 to 200.090, 236.605 to 236.640, 243.650 to 243.782,
 40 297.040, 307.090 and 307.112 and ORS chapters 35, 190, 192, 244 and 295 apply to the University
 41 of Oregon under the same terms as they apply to public bodies other than the state.

42 (2) Notwithstanding subsection (1) of this section, ORS 190.430 and 192.105 do not apply
 43 to the university or any not-for-profit organization or other entity if the equity of the entity
 44 is owned exclusively by the university and if the organization or entity is created by the
 45 university to advance any of the university's statutory missions.

1 (3) Except as otherwise provided by law, the provisions of ORS 35.550 to 35.575, 180.060,
 2 180.210 to 180.235, 184.305 to 184.345, 190.480, 190.490, 200.035, 243.105 to 243.585, 243.696, 279.835
 3 to 279.855, 357.805 to 357.895 and 656.017 (2) and ORS chapters 182, 183, 240, 270, 273, 276, 278,
 4 279A, 279B, 279C, 282, 283, 291, 292, 293, 294 and 297 do not apply to the university or any
 5 not-for-profit organization or other entity if the equity of the entity is owned exclusively by
 6 the university and if the organization or entity is created by the university to advance any
 7 of the university's statutory missions.

8 (4) Notwithstanding subsections (3) and (5) of this section, ORS 279B.055 (3), 279C.380
 9 (1)(a) and (3), 279C.600 to 279C.625, 279C.800, 279C.810, 279C.825, 279C.830, 279C.835, 279C.840,
 10 279C.845, 279C.850, 279C.855, 279C.860, 279C.865 and 279C.870 apply to the university under the
 11 same terms as they apply to public bodies other than the state.

12 (5) The university, as a distinct governmental entity, or any organization or entity de-
 13 scribed in subsection (2) of this section is not subject to any provision of law enacted after
 14 January 1, 2011, with respect to any governmental entity, that is unique to governmental
 15 entities, unless the provision specifically provides that it applies to the university or to the
 16 organization or entity.

17 **SECTION 10.** (1) Notwithstanding section 9 of this 2011 Act, ORS 243.105 to 243.585 apply
 18 to the University of Oregon under the same terms as they apply to public bodies other than
 19 the state, until the University of Oregon Board of Directors, in accordance with the pro-
 20 visions of any collective bargaining agreement, adopts a new personnel system or alternative
 21 employee benefit plan. Until such time as a new personnel system is adopted, the university
 22 shall exercise exclusive administrative authority and control over the existing personnel
 23 system, consistent with the provisions of ORS 243.105 to 243.585.

24 (2) Notwithstanding section 9 of this 2011 Act, collective bargaining agreements negoti-
 25 ated by this state pursuant to ORS 240.321 after the effective date of this 2011 Act that are
 26 applicable to employees of the Oregon University System apply to the University of Oregon
 27 if the new collective bargaining agreement is a successor to a collective bargaining agree-
 28 ment negotiated by this state and applicable to the same class of employees of the university
 29 prior to the effective date of this 2011 Act. Such successor agreements shall continue to ap-
 30 ply to the university until the board and the applicable collective bargaining organization
 31 agree to bargain a separate collective bargaining agreement between the university and the
 32 collective bargaining organization.

33 **SECTION 11.** (1) As used in this section:

34 (a) "Direct labor" includes all work required for preparation, processing and packing, but
 35 not supervision, administration, inspection or shipping.

36 (b) "Individual with a disability" means an individual who, because of the nature of the
 37 individual's disability, is not able to participate fully in competitive employment and for
 38 whom specialized employment opportunities must be provided.

39 (c) "Qualified nonprofit agency for individuals with disabilities" means a nonprofit activ-
 40 ity center or rehabilitation facility:

41 (A) Organized under the laws of the United States or of this state and operated in the
 42 interest of individuals with disabilities, the net income of which does not inure in whole or
 43 in part to the benefit of any shareholder or other individual;

44 (B) That complies with any applicable occupational health and safety standards required
 45 by the laws of the United States or of this state; and

1 (C) That in the manufacture of products and in the provision of services during the fiscal
2 year employs individuals with disabilities for not less than 75 percent of the work hours of
3 direct labor required for the manufacture or provision of the products or services.

4 (2) The University of Oregon Board of Directors shall further the policy of this state to
5 encourage and assist individuals with disabilities to achieve maximum personal independence
6 through useful and productive gainful employment by ensuring an expanded and constant
7 market for sheltered workshop and activity center products and services, thereby enhancing
8 the dignity and capacity of individuals with disabilities for self-support and minimizing their
9 dependence on welfare and need for costly institutionalization.

10 (3) It shall be the duty of the University of Oregon to:

11 (a) Determine the price of all products manufactured and services offered for sale to the
12 university by any qualified nonprofit agency for individuals with disabilities. The price shall
13 recover for the workshops the cost of raw materials, labor, overhead, delivery costs and a
14 margin held in reserve for inventory and equipment replacement.

15 (b) Revise such prices from time to time in accordance with changing cost factors.

16 (c) Make such rules regarding specifications, time of delivery and other relevant matters
17 of procedure as shall be necessary.

18 (d) Utilize prices and specifications, in its discretion, established by the Oregon Depart-
19 ment of Administrative Services.

20 (4) The university shall establish and publish a list of sources or potential sources of
21 products produced by any qualified nonprofit agency for individuals with disabilities and the
22 services provided by any such agency that the university determines are suitable for its
23 procurement. The university, in its discretion, may utilize any list established and published
24 by the department.

25 (5) If the university intends to procure any product or service on the procurement list,
26 the university shall procure such product or service at the price established by the university
27 from a qualified nonprofit agency for individuals with disabilities, provided the product or
28 service is of the appropriate specifications and is available at the location and within the
29 period required by the university.

30 (6) It is the intent of the Legislative Assembly that there be close cooperation between
31 the board, the university and qualified nonprofit agencies for individuals with disabilities.
32 The university, on behalf of the board, is authorized to enter into such contractual ar-
33 rangements, cooperative working relationships or other arrangements as may be necessary
34 for effective coordination and efficient realization of the objective of this section.

35 **SECTION 12.** The University of Oregon Board of Directors shall file with the Legislative
36 Assembly and the Governor, not later than April 15 of each year, a report of the activities
37 and operations of the University of Oregon for the preceding year.

38 **SECTION 13.** (1) The University of Oregon Board of Directors may lease, purchase or
39 otherwise acquire such real property as in its sole discretion is necessary or convenient to
40 carry out any power granted to the university. The board may enter into contracts of pur-
41 chase or agreements that the board deems necessary to carry out this authorization. The
42 board may mortgage or pledge any property so purchased, or its contracts to purchase, to-
43 gether with the income from such property, to secure the payment of the purchase price
44 thereof.

45 (2) Legal title to all real property acquired by the University of Oregon after the effective

1 date of this 2011 Act shall be taken and held in the name of the university. Legal title to all
2 real property of this state held or managed for the use and benefit of the university as of
3 the effective date of this 2011 Act shall continue to be vested in this state.

4 (3) The board may lease, sell, convey and control the use of, in whole or in part, all
5 property of this state held or managed for the use and benefit of the university as of the
6 effective date of this 2011 Act or that is acquired by the university after the effective date
7 of this 2011 Act. Authorized conveyances of all real property acquired by or vested in this
8 state for the use or benefit of the university or acquired by or vested in the university, other
9 than the state lands classified as university lands under ORS 273.251, shall be executed by
10 the chairperson and secretary of the board.

11 (4) Except as otherwise provided by law, proceeds from the lease, sale or conveyance of
12 real property pursuant to subsection (3) of this section shall be deposited into an account
13 at the University of Oregon for the benefit of the university.

14 SECTION 14. The University of Oregon Board of Directors may, in the management of
15 all forestlands under its control and supervision, sell the forest products on such lands. In
16 the management of its forestlands, the board may lease mineral and geothermal resource
17 rights.

18 SECTION 15. The University of Oregon may acquire, by condemnation or otherwise, pri-
19 vate property that is necessary or convenient in carrying out any power granted to the uni-
20 versity.

21 SECTION 16. The University of Oregon shall adopt a comprehensive alcohol and drug
22 abuse policy and implementation plan.

23 SECTION 17. (1) The University of Oregon shall develop contract policies that support
24 openness, impartiality and competition in the awarding of contracts in accordance with ORS
25 279A.015.

26 (2) The university shall also develop contract policies that are designed to encourage af-
27 firmative action, recycling, inclusion of art in public buildings, the purchase of goods and
28 services from individuals with disabilities, the protection of workers through the payment
29 of prevailing wages as determined by the Bureau of Labor and Industries, the provision of
30 workers' compensation insurance to workers on contracts and the participation of emerging
31 small businesses and businesses owned by women and minorities.

32 (3) The University of Oregon Board of Directors shall have the authority to enact poli-
33 cies, appropriate for the use of the university, governing public contracting and may devise
34 and publish forms for use in carrying out the policies.

35 SECTION 18. (1) On or before September 1 of each even-numbered year the University
36 of Oregon shall submit to the Oregon Department of Administrative Services a funding re-
37 quest for the following biennium. The department shall include and submit the university's
38 funding request to the Legislative Assembly as part of the Governor's biennial budget. Any
39 such request approved by the Legislative Assembly shall be appropriated to the department
40 for direct allocation to the university. The budget request to the Legislative Assembly shall
41 include a presentation on tuition and student fee levels.

42 (2) The University of Oregon Board of Directors is not required to seek expenditure
43 limitation approval from the Legislative Assembly to spend other available moneys, including
44 without limitation tuition and other fees or revenues collected pursuant to the board's au-
45 thority under section 7 of this 2011 Act.

1 (3) The University of Oregon Board of Directors shall adopt a budget on a regular
2 schedule determined by the board.

3 **SECTION 19.** (1) The University of Oregon may conduct independent audits if such audits
4 are considered advisable by the university. The audits are subject to the exclusive discretion
5 and control of the university and are subject to disclosure pursuant to ORS 192.410 to 192.505.

6 (2) Nothing in this section affects the constitutional duties and authority of the Secretary
7 of State to audit public accounts.

8 **SECTION 20.** The University of Oregon may commission special campus security officers
9 with authority and immunities set forth in ORS 352.385 and police officers. University police
10 officers commissioned under this section shall have all the powers, authority and immunities
11 given by statute to peace officers and police officers of this state. University police officers
12 shall complete training necessary for certification as police officers at an academy operated
13 or authorized by the Department of Public Safety Standards and Training at the expense of
14 the University of Oregon Board of Directors. University police officers are not police officers
15 for purposes of ORS 238.005, 243.005 or 243.736. The university police department is a crimi-
16 nal justice agency and a law enforcement unit.

17 **SECTION 21.** (1) The University of Oregon Board of Directors may enact such regulations
18 as the board deems convenient or necessary to provide for the policing, control and regu-
19 lation of traffic and parking of vehicles on University of Oregon property. The regulations
20 may provide for the registration of vehicles, the designation of parking areas and the as-
21 sessment and collection of reasonable fees and charges for parking. The board may require
22 that before a quarterly or yearly parking privilege for any vehicle is granted to any full-time
23 or part-time student to use board property, the student must show that the vehicle is oper-
24 ated by a student holding a valid driver's license, that the vehicle is currently registered and
25 that the student driving the vehicle is insured under a motor vehicle liability insurance policy
26 that meets the requirements described in ORS 806.080 or that the student or owner of the
27 vehicle has provided the Department of Transportation with other satisfactory proof of
28 compliance with the financial responsibility requirements of this state.

29 (2) The regulations enacted pursuant to subsection (1) of this section shall be enforced
30 administratively under procedures adopted by the board. Administrative and disciplinary
31 sanctions may be imposed upon students, faculty and staff for violation of the regulations,
32 including, but not limited to, a reasonable monetary penalty that may be deducted from
33 student deposits and faculty or staff salaries or other funds in the possession of the univer-
34 sity. The board shall provide opportunity for hearing for the determination of controversies
35 in connection with imposition of fines or penalties. Persons other than students, faculty or
36 staff may voluntarily submit to the hearing procedures prescribed by the board, and shall
37 be bound by the results of the hearing. The powers granted to the board by this section are
38 supplemental to the existing powers of the board with respect to the governance of activities
39 of students, faculty and staff and the control and management of property under the board's
40 jurisdiction.

41 (3) The regulations enacted pursuant to subsection (1) of this section may also be en-
42 forced by the impoundment of vehicles, and a reasonable fee may be enacted for the cost of
43 impoundment and storage, if any, prior to the release of the vehicles to their owners.

44 (4) Every peace officer may enforce the regulations made by the board under subsection
45 (1) of this section. The board, for the purpose of enforcing its regulations governing traffic

1 control, may appoint peace officers who have the same authority as other peace officers as
2 defined in ORS 133.005.

3 (5) The board and any municipal corporation or any department, agency or political sub-
4 division of this state may enter into agreements or contracts for the purpose of providing a
5 uniform system of enforcement of the regulations of the board enacted pursuant to sub-
6 section (1) of this section.

7 (6) In proceedings brought to enforce regulations enacted pursuant to subsection (1) of
8 this section, it shall be sufficient to charge the defendant by an unsworn written notice as
9 provided by law. Proceedings to enforce regulations enacted pursuant to subsection (1) of
10 this section may be brought in the name of the board in a circuit court, a justice court or
11 a municipal court for offenses committed within the territorial jurisdiction of such court.
12 Such courts shall have concurrent jurisdiction over offenses committed within their respec-
13 tive jurisdictions. All fines, penalties and court costs recovered shall be paid to the clerk of
14 the court involved and shall be disposed of as provided by law.

15 **SECTION 22.** (1) For the purpose of requesting a state or nationwide criminal records
16 check under ORS 181.534, the University of Oregon may require the fingerprints of a person
17 who:

18 (a)(A) Is employed or applying for employment by the university; or

19 (B) Provides services or seeks to provide services to the university as a contractor or
20 volunteer; and

21 (b) Is, or will be, working or providing services in a position that is designated as a
22 critical or security-sensitive position.

23 (2) For the purposes of this section, "critical or security-sensitive position" means a po-
24 sition in which the person:

25 (a) Has direct access to persons under 18 years of age, or has direct access to student
26 residence facilities because the person's work duties require the person to be present in the
27 residence facility;

28 (b) Is providing information technology services and has control over, or access to, in-
29 formation technology systems that would allow the person to harm the information tech-
30 nology systems or the information contained in the systems;

31 (c) Has access to information, the disclosure of which is prohibited by state or federal
32 laws, rules or regulations or information that is defined as confidential under state or federal
33 laws, rules or regulations;

34 (d) Has access to property where chemicals, hazardous materials and other items con-
35 trolled by state or federal laws or regulations are located;

36 (e) Has access to laboratories, nuclear facilities or utility plants to which access is re-
37 stricted to protect the health or safety of the public;

38 (f) Has financial, financial aid, payroll or purchasing responsibilities as one of the
39 person's primary responsibilities; or

40 (g) Has access to personal information about university employees or members of the
41 public including Social Security numbers, dates of birth, driver license numbers, medical in-
42 formation, personal financial information or criminal background information.

43 **SECTION 23.** The University of Oregon Board of Directors may open, establish, lay out
44 and dedicate to the public use any streets through lands owned by or used for the University
45 of Oregon. When such streets are opened, established and laid out, they are declared to be

1 dedicated to the public use. The university shall be the road authority pursuant to ORS
2 810.010 (4) for all roads through lands owned by or used for the university.

3 **SECTION 24.** The University of Oregon may adopt policies relating to the creation, use,
4 custody and disclosure of, including access to, student education records of the university
5 that are consistent with the requirements of applicable state and federal law. Whenever a
6 student has attained 18 years of age or is attending the university, the permission or consent
7 required of and the rights accorded to a parent of the student regarding education records
8 is thereafter only required of and accorded to the student.

9 **SECTION 25.** (1) The University of Oregon may not refuse admission or expel a student
10 for the sole reason that, because of religious beliefs, the student is unable to attend classes
11 on a particular day.

12 (2) Any student at the university who, because of religious beliefs, is unable to attend
13 classes on a particular day, must be excused on that day from any examination, study re-
14 quirement or work requirement. However, at the student's own expense, the student may
15 be required to make up the examination, study requirement or work requirement missed
16 because of the absence.

17 **SECTION 26.** (1) A student at the University of Oregon who is a member of the military
18 and who is ordered to federal or state active duty for more than 30 consecutive days has the
19 following rights:

20 (a) With regard to a course in which the student is enrolled and for which the student
21 has paid tuition and fees, the right to:

22 (A) Withdraw from the course, subject to the provisions of subsection (2) of this section;

23 (B) Receive a grade of incomplete and, upon release from active duty, complete the
24 course in accordance with the university's practice for completion of incomplete courses; or

25 (C) Continue and complete the course for full credit, subject to the provisions of sub-
26 section (3) of this section;

27 (b) The right to a credit described in section 27 of this 2011 Act for all amounts paid for
28 room, board, tuition and fees;

29 (c) If the student elects to withdraw from the university, the right to be readmitted and
30 reenrolled at the university within one year after release from active duty without a re-
31 quirement for redetermination of admission eligibility; and

32 (d) The right to continuation of scholarships and grants awarded to the student that were
33 funded by the university or the Oregon Student Assistance Commission before the student
34 was ordered to active duty.

35 (2) If the student elects to withdraw from a course under subsection (1)(a)(A) of this
36 section, the university may not:

37 (a) Give the student academic credit for the course from which the student withdraws;

38 (b) Give the student a failing grade or a grade of incomplete or make any other negative
39 annotation on the student's record; or

40 (c) Alter the student's grade point average due to the student's withdrawal from the
41 course.

42 (3) A student who elects to continue and complete a course for full credit under sub-
43 section (1)(a)(C) of this section is subject to the following conditions:

44 (a) Course sessions the student misses due to active duty shall be counted as excused
45 absences and may not adversely impact the student's grade for the course or rank in the

1 student's class.

2 (b) The student may not be automatically excused from completing course assignments
3 due during the period the student serves on active duty.

4 (c) A letter grade or a grade of pass may be awarded only if, in the opinion of the teacher
5 of the course, the student completes sufficient work and demonstrates sufficient progress
6 toward meeting course requirements to justify the grade.

7 (4) The University of Oregon Board of Directors shall adopt rules for the administration
8 of this section.

9 (5) As used in this section, "member of the military" means a person who is a member
10 of:

11 (a) The Oregon National Guard or the National Guard of any other state or territory; or

12 (b) The reserves of the Army, Navy, Air Force, Marine Corps or Coast Guard of the
13 United States.

14 **SECTION 27.** (1)(a) The amount of the credit specified in section 26 (1)(b) of this 2011 Act
15 shall be based on:

16 (A) The amount of room and board paid by the student for a term that the student does
17 not complete because the student is ordered to active duty; and

18 (B) The amount of tuition and fees paid by the student for a course from which the
19 student withdraws.

20 (b) The amount of the credit shall be prorated based on the number of weeks remaining
21 in the term or course when the student withdraws.

22 (c) At the time a student withdraws from a course at the University of Oregon or from
23 the university, the student must elect to claim the credit:

24 (A) As a credit toward tuition and fees or room and board if the student reenrolls at the
25 university under section 26 (1)(c) of this 2011 Act; or

26 (B) As a monetary payment.

27 (2) A student who elects to claim the credit by the method described in subsection
28 (1)(c)(A) of this section may change the method of claiming the credit to the method de-
29 scribed in subsection (1)(c)(B) of this section by giving notice to the university.

30 (3) A student who elects to claim the credit by the method described in subsection
31 (1)(c)(A) of this section must use the credit or change the method of claiming the credit
32 under subsection (2) of this section within one year after release from active duty.

33 (4) A personal representative of a student who elected to claim the credit by the method
34 described in subsection (1)(c)(A) of this section may claim a monetary payment upon pre-
35 senting evidence to the university that the student died while serving on active duty.

36 (5) The University of Oregon Board of Directors shall adopt rules for the administration
37 of this section, including rules that determine the amount of credit and the method by which
38 the credit is prorated.

39 **SECTION 28.** The University of Oregon shall give credit for education and training ob-
40 tained by a person while serving in the Armed Forces of the United States, as defined in ORS
41 351.642. The education and training for which credit may be given must meet the standards
42 adopted by the University of Oregon Board of Directors.

43 **SECTION 29.** (1) The University of Oregon shall charge an enrolled student who is not a
44 resident of this state and who is attending classes as an undergraduate tuition and fees no
45 greater than the resident rate plus 50 percent of the difference between the resident rate

1 and the nonresident rate if the student served in the Armed Forces of the United States and
2 was relieved or discharged from that service under honorable conditions.

3 (2) The university shall participate to the fullest extent allowed in the federal educational
4 assistance programs under the Supplemental Appropriations Act of 2008 (P.L. 110-252) so as
5 to reduce the overall tuition rate for students eligible for tuition rate reduction under sub-
6 section (1) of this section to the resident tuition rate.

7 (3) A person who served in the Armed Forces of the United States and who receives
8 federal tuition benefits in excess of the tuition and fees the person is charged under sub-
9 section (1) of this section at the university shall pay tuition and fees equal to the federal
10 tuition benefits received.

11 (4) Distance education and self-support courses as identified by the university are exempt
12 from the tuition reduction provisions of this section.

13 (5) If a nonresident student otherwise eligible for tuition benefits under this section is
14 receiving federal vocational rehabilitation education benefits, that student shall pay full
15 nonresident tuition and fees charged by the University of Oregon.

16 **SECTION 30.** (1) The University of Oregon shall convene a physical access committee to
17 identify barriers to access by persons with disabilities at the university. The committee shall
18 include, but not be limited to:

19 (a) One or more students with disabilities or, if there are no students with disabilities
20 willing to participate, a person with a disability who uses the university's facilities;

21 (b) One or more members of the faculty or staff who have disabilities;

22 (c) The coordinator of services for students with disabilities for the university;

23 (d) One or more administrators of the university; and

24 (e) One or more members of the physical plant staff of the university.

25 (2) The physical access committee shall present its findings and recommendations to the
26 University of Oregon Board of Directors, listing access needs and priorities for meeting those
27 needs. These findings and recommendations shall identify the barriers to access that prevent
28 persons with disabilities from meaningfully utilizing campus facilities related to instruction,
29 academic support, assembly and residence life.

30 (3) In preparing budget requests for each biennium, the university shall include amounts
31 for capital improvement that will be applied to the substantial reduction and eventual elimi-
32 nation of barriers to access by persons with disabilities as identified by the physical access
33 committee.

34 (4) Nothing in this section and ORS 185.155 and 341.937 requires the university to under-
35 take projects for accessibility that are not otherwise required unless such projects are
36 funded specifically by the Legislative Assembly.

37 **SECTION 31.** Notwithstanding the provisions of ORS chapters 238 and 238A, the Univer-
38 sity of Oregon may offer to its employees, in addition to the Public Employees Retirement
39 System, alternative retirement programs.

40 **SECTION 32.** (1) The University of Oregon Board of Directors may adopt policies gov-
41 erning access to University of Oregon personnel records that are less than 25 years old.

42 (2) Policies adopted under subsection (1) of this section shall require that personnel re-
43 cords be subjected to restrictions on access unless the president of the university finds that
44 the public interest in maintaining individual rights to privacy in an adequate educational
45 environment would not suffer by disclosure of such records. Access to such records may be

1 limited to designated classes of information or persons, or to stated times and conditions,
2 or to both, but cannot be limited for records more than 25 years old.

3 (3) No rule or order adopted pursuant to this section shall deny to a faculty member full
4 access to the member's personnel file or records kept by the university, except as provided
5 in subsection (4)(d) and (e) of this section.

6 (4)(a) The files relating to the evaluation of a faculty member shall be kept in designated,
7 available locations.

8 (b) Any evaluation received by telephone shall be documented in each of the faculty
9 member's files by means of a written summary of the conversation with the names of the
10 conversants identified.

11 (c) A faculty member shall be entitled to submit, for placement in the files, evidence re-
12 butting, correcting, amplifying or explaining any document contained therein and other ma-
13 terial that the member believes might be of assistance in the evaluation process.

14 (d) Letters and other information for a faculty member of the university submitted in
15 confidence to the State Board of Higher Education or its institutions, schools or departments
16 prior to July 1, 1975, shall be maintained in the files designated by paragraph (a) of this
17 subsection. However, if a faculty member requests access to those files, the anonymity of
18 the contributor of letters and other information obtained prior to July 1, 1975, shall be pro-
19 tected. The full text shall be made available, except that portions of the text that would serve
20 to identify the contributor shall be excised by a faculty committee. Only the names of the
21 contributors and the excised portions of the documents may be kept in a file other than the
22 files designated by paragraph (a) of this subsection.

23 (e) Confidential letters and other information submitted to or solicited by the university
24 after July 1, 2011, and prior to the employment of a prospective faculty member are exempt
25 from the provisions of this paragraph. However, if the member is employed by the university,
26 the confidential preemployment materials shall be placed in the files designated by paragraph
27 (a) of this subsection. If a faculty member requests access to the member's files, the ano-
28 nymity of the contributor of confidential preemployment letters and other preemployment
29 information shall be protected. The full text shall be made available, except that portions of
30 the text that would serve to identify the contributor shall be excised and retained in a file
31 other than the files designated by paragraph (a) of this subsection.

32 (f) Classroom survey evaluations by students of a faculty member's classroom or labo-
33 ratory performance shall be anonymous. The record of tabulated reports shall be placed in
34 at least one of the files designated by paragraph (a) of this subsection. All survey instru-
35 ments used to obtain evaluation data shall be returned to the faculty member.

36 (g) The university, when evaluating its employed faculty members, may not solicit or
37 accept letters, documents or other materials, given orally or in written form, from individ-
38 uals or groups who wish their identity kept anonymous or the information they provide kept
39 confidential.

40 (5) A policy or order adopted pursuant to this section does not limit the authority of the
41 university to prepare, without identification of individual persons who have not consented
42 thereto, statistical or demographic reports from personnel records.

43 (6) Any category of personnel records specifically designated as confidential pursuant to
44 valid policies or orders as provided in this section may not be deemed a public record for the
45 purposes of ORS 192.420.

1 (7) As used in this section, “personnel records” means records containing information
 2 kept by the university concerning a faculty member and furnished by the faculty member
 3 or by others about the faculty member at the member’s or at the university’s request, in-
 4 cluding but not limited to information concerning discipline, membership activity and em-
 5 ployment performance, or other personal records of individual persons.

6 **SECTION 33.** (1) The University of Oregon Board of Directors may authorize receipt of
 7 compensation for any officer or employee from private or public resources, including, but
 8 not limited to, income from:

9 (a) Consulting;

10 (b) Appearances and speeches;

11 (c) Intellectual property conceived, reduced to practice or originated and therefore owned
 12 within the University of Oregon;

13 (d) Providing services or other valuable consideration for a private corporation, individual
 14 or entity, whether paid in cash or in-kind, stock or other equity interest, or anything of
 15 value regardless of whether there is a licensing agreement between the university and the
 16 private entity; and

17 (e) Performing public duties paid by private organizations, including university corporate
 18 affiliates, that augment an officer’s or employee’s publicly funded salary. Such income shall
 19 be authorized and received in accordance with policies and rules established by the board.

20 (2) The board may not authorize compensation, as described in subsection (1) of this
 21 section, that, in the board’s judgment, does not comport with the mission of the university
 22 or substantially interferes with an officer’s or employee’s duties to the university.

23 (3) Any compensation described and authorized under subsection (1) of this section is
 24 considered official compensation or reimbursement of expenses for purposes of ORS 244.040
 25 and is not considered an honorarium prohibited by ORS 244.042. If authorization or receipt
 26 of the compensation creates a potential conflict of interest, the officer or employee shall
 27 report the potential conflict in writing in accordance with rules of the board. The disclosure
 28 is a public record subject to public inspection.

29 (4) The board shall adopt by rule standards governing employee outside employment and
 30 activities, including potential conflicts of interest, as defined by board rule and consistent
 31 with ORS 244.020, and the public disclosure thereof, and procedures for reporting and hearing
 32 potential or actual conflict of interest complaints.

33 **SECTION 34.** The president and professors constitute the faculty of the University of
 34 Oregon and have the immediate government and discipline of it and the students therein.
 35 The faculty may, subject to the supervision of the University of Oregon Board of Directors,
 36 prescribe the course of study to be pursued at the university and the textbooks to be used.

37 **SECTION 35.** The University of Oregon shall consider and maintain affirmative action
 38 plans and goals when reductions in faculty and staff are required as a result of:

39 (1) Reductions in revenue that necessitate discontinuance of the university’s educational
 40 program at its anticipated level;

41 (2) Elimination of classes due to decreased student enrollment; or

42 (3) Reduction in courses due to administrative decisions.

43 **SECTION 36.** A political or sectarian test may never be allowed or applied in the ap-
 44 pointment of faculty and other employees of the University of Oregon.

45 **SECTION 37.** (1) Nothing in sections 1 to 52 of this 2011 Act may be construed to impair

1 the obligations or agreements of the State of Oregon or the State Board of Higher Education
2 with respect to bonds, certificates of participation, financing agreements or other agree-
3 ments for the borrowing of money issued prior to the effective date of this 2011 Act by the
4 State of Oregon on behalf of the State Board of Higher Education for equipment or projects
5 for the University of Oregon. The university and the Oregon University System shall take
6 all actions necessary to ensure full compliance with all indentures, resolutions, declarations,
7 agreements and other documents issued with respect to the bonds, certificates of partic-
8 ipation, financing agreements or other agreements for the borrowing of money issued prior
9 to the effective date of this 2011 Act by the State of Oregon on behalf of the State Board of
10 Higher Education for equipment or projects for the university. The Oregon University Sys-
11 tem and the university shall establish, in a written agreement that shall be subject to the
12 approval of the State Treasurer, the responsibility of the university for the payment to the
13 State Board of Higher Education of moneys sufficient to pay when due all principal, interest
14 and any other charges on bonds, certificates of participation, financing agreements or other
15 agreements for the borrowing of money issued prior to the effective date of this 2011 Act by
16 the State of Oregon on behalf of the State Board of Higher Education for equipment or
17 projects for the university.

18 (2) Holders of obligations issued by the university on or after the effective date of this
19 2011 Act may be paid on an equal footing with the obligations issued by the State of Oregon
20 on behalf of the State Board of Higher Education for equipment or projects for the university
21 prior to the effective date of this 2011 Act from the rents, revenues, receipts, appropriations
22 or other income of the university, but only to the extent that:

23 (a) Such holders have no rights, liens or other interests with respect to such rents, re-
24 venues, receipts, appropriations or other income of the university that are senior or superior
25 to the rights granted to the holders of obligations issued prior to the effective date of this
26 2011 Act by the State of Oregon on behalf of the State Board of Higher Education for
27 equipment or projects for the university; and

28 (b) The State Board of Higher Education, the Oregon Department of Administrative
29 Services or the State of Oregon, acting for the benefit of such holders of obligations, is
30 granted a lien or other security interest in the rents, revenues, receipts, appropriations or
31 other income of the university that is not junior to and is at least on an equal footing with
32 any lien or other security interest granted to the holders of obligations issued by the uni-
33 versity.

34 (3) Any expenses, including legal expenses, judgments, liabilities and federal arbitrage and
35 rebate penalties arising from the actions of the university, if incurred with respect to bonds,
36 certificates of participation, financing agreements or other agreements for the borrowing of
37 money issued prior to the effective date of this 2011 Act by the State of Oregon on behalf
38 of the State Board of Higher Education for equipment or projects for the university, shall
39 be paid when due by the university, subject to the university's right to reasonably contest
40 such charges, judgments, liabilities or penalties. The university shall assist the Controller
41 of the Oregon University System in making any necessary calculations and filing any neces-
42 sary reports related to arbitrage and rebate on such indebtedness.

43 (4) Any amounts deposited with the State Treasurer, the Controller of the Oregon Uni-
44 versity System, the Oregon Department of Administrative Services or its designated agents
45 in any debt service in reserve accounts for the debt service associated with any bonds, cer-

1 tificates of participation, financing agreements or other agreements for the borrowing of
2 money issued prior to the effective date of this 2011 Act by the State of Oregon on behalf
3 of the State Board of Higher Education for equipment or projects for the university shall
4 remain with the State Treasurer, the Controller of the Oregon University System, the
5 Oregon Department of Administrative Services or its designated agents until such time as
6 the bonds, certificates of participation, financing agreements or other agreements for the
7 borrowing of money for which such reserve accounts have been established have been retired
8 or defeased. The university shall be credited with the investment earnings on such reserve
9 accounts.

10 **SECTION 38.** The University of Oregon may from time to time issue and sell revenue
11 bonds in accordance with ORS chapter 287A. However, the provisions contained in ORS
12 287A.150 (2) to (6) do not apply to revenue bonds issued by the university. Such revenue
13 bonds are neither a general obligation of the university nor a charge upon any revenues or
14 property of the university not specifically pledged thereto. An obligation described in this
15 section is not an indebtedness of the State of Oregon.

16 **SECTION 39.** Revenue bonds issued by the University of Oregon under ORS chapter 287A
17 are considered to be bonds or obligations of a political subdivision of the State of Oregon for
18 the purposes of all laws of the state.

19 **SECTION 40.** Refunding bonds and advance refunding bonds of the same character and
20 tenor as those replaced by them may be issued by the University of Oregon pursuant to ORS
21 287A.360 to 287A.380.

22 **SECTION 41.** In addition to, and not in limitation of, the means of satisfying state gen-
23 eral obligation bond obligations under ORS 291.445, the University of Oregon, promptly upon
24 the discovery of any shortfall in moneys available to the university for the payment when
25 due of amounts under any bonds, certificates of participation, financing agreements or other
26 agreements for the borrowing of moneys issued prior to the effective date of this 2011 Act
27 by the State of Oregon on behalf of the State Board of Higher Education for equipment or
28 projects for the university, shall notify in writing the Legislative Assembly, or if the Legis-
29 lative Assembly is not in session, the Emergency Board, of the existence and amount of the
30 shortfall. The Legislative Assembly or the Emergency Board, as the case may be, may pro-
31 vide funds to satisfy the payment of any such amount. By enacting this provision, the Leg-
32 islative Assembly acknowledges its current intention to provide, from funds other than those
33 appropriated or otherwise made available to the Oregon University System, funds to pay such
34 amount. However, except as may be required by the Oregon Constitution or ORS 291.445,
35 neither the Legislative Assembly nor the Emergency Board shall have any legal obligation
36 to provide funds under this section.

37 **SECTION 42.** In order to provide funds for the purposes specified in Article XI-G of the
38 Oregon Constitution, the University of Oregon Board of Directors may request the State
39 Treasurer to issue bonds in accordance with the provisions of ORS chapter 286A.

40 **SECTION 43.** In order to provide funds for the purposes specified in Article XI-F(1) of the
41 Oregon Constitution, the University of Oregon Board of Directors may request the State
42 Treasurer to issue bonds in accordance with the provisions of ORS chapter 286A.

43 **SECTION 44.** If the electors of this state authorize the issuance of bonds for the benefit
44 of the University of Oregon individually or in its capacity as a public university, the Uni-
45 versity of Oregon Board of Directors may request the State Treasurer to issue bonds for

1 such purposes in accordance with the provisions of ORS chapter 286A.

2 **SECTION 45.** As used in sections 45 to 49 of this 2011 Act:

3 (1) "Credit enhancement agreement" means any agreement or contractual relationship
4 between the University of Oregon and any bank, trust company, insurance company, surety
5 bonding company, pension fund or other financial institution providing additional credit on
6 or security for a financing agreement or certificates of participation authorized by sections
7 45 to 49 of this 2011 Act.

8 (2) "Financing agreement" means a lease-purchase agreement, an installment sale
9 agreement, a loan agreement, a note agreement, short-term promissory notes, commercial
10 papers, lines of credit or similar obligations or any other agreement to finance real or per-
11 sonal property that is or will be owned and operated by the university, or to refinance pre-
12 viously executed financing agreements.

13 (3) "Personal property" means tangible personal property, software and fixtures.

14 (4) "Property rights" means, with respect to personal property, the rights of a secured
15 party under ORS chapter 79, and, with respect to real property, the rights of a trustee or
16 lender under a lease authorized by section 48 (4) of this 2011 Act.

17 (5) "Software" means software and training and maintenance contracts related to the
18 operation of computing equipment.

19 **SECTION 46.** The University of Oregon may enter into financing agreements in accord-
20 ance with sections 45 to 49 of this 2011 Act, upon such terms as the university finds to be
21 advantageous. Amounts payable by the university under a financing agreement shall be
22 limited to funds specifically pledged, budgeted for or otherwise made available by the uni-
23 versity. If there are insufficient funds available to pay amounts due under a financing
24 agreement, the lender may exercise any property rights that the university has granted to
25 it in the financing agreement against the property that was purchased with the proceeds of
26 the financing agreement, and may apply the amounts so received toward payments scheduled
27 to be made by the university under the financing agreement.

28 **SECTION 47.** The University of Oregon Board of Directors may delegate to any board
29 member or the president's designee the authority to determine maturity dates, principal
30 amounts, redemption provisions, interest rates or methods for determining variable or ad-
31 justable interest rates, denominations and other terms and conditions of such obligations
32 that are not appropriately determined at the time of enactment or adoption of the author-
33 izing resolution. The board may also delegate entering into financing agreements or any
34 other instruments authorized by law. This delegated authority shall be exercised subject to
35 applicable requirements of law and such limitations and criteria as may be set forth in the
36 authorizing resolution.

37 **SECTION 48.** The University of Oregon may:

38 (1) Enter into agreements with third parties to hold financing agreement proceeds, pay-
39 ments and reserves as security for lenders, and to issue certificates of participation in the
40 right to receive payments due from the university under a financing agreement. Amounts
41 so held shall be invested at the direction of the University of Oregon Board of Directors.
42 Interest earned on any investments held as security for a financing agreement may, at the
43 option of the board, be credited to the accounts held by the third party and applied in pay-
44 ment of sums due under a financing agreement.

45 (2) Enter into credit enhancement agreements for financing agreements or certificates

1 of participation, provided that such credit enhancement agreements shall be payable solely
2 from funds specifically pledged, budgeted for or otherwise made available by the university
3 and amounts received from the exercise of property rights granted under such financing
4 agreements.

5 (3) Use financing agreements to finance the costs of acquiring or refinancing real or
6 personal property, plus the costs of reserves, credit enhancements and costs associated with
7 obtaining the financing.

8 (4) Grant leases of real property with a trustee or lender. Such leases may be for a term
9 that ends on the date on which all amounts due under a financing agreement have been paid
10 or provision for payment has been made, or up to 20 years after the last scheduled payment
11 under a financing agreement, whichever is later. Such leases may grant the trustee or lender
12 the right to evict the university and exclude it from possession of the real property for the
13 term of the lease if the university fails to pay when due the amounts scheduled to be paid
14 under a financing agreement, or otherwise defaults under a financing agreement. Upon de-
15 fault, the trustee or lender may sublease the land to third parties and apply any rentals to-
16 ward payments scheduled to be made under a financing agreement.

17 (5) Grant security interests in personal property to trustees or lenders.

18 (6) Make pledges for the benefit of trustees and lenders.

19 (7) Purchase fire and extended coverage or other casualty insurance for property that is
20 acquired or refinanced with proceeds of a financing agreement, assign the proceeds thereof
21 to a lender or trustee to the extent of their interest, and covenant to maintain such insur-
22 ance while the financing agreement is unpaid, so long as available funds are sufficient to
23 purchase such insurance.

24 SECTION 49. A lease or financing agreement under sections 45 to 49 of this 2011 Act does
25 not cause property to be subject to property taxation and is disregarded in determining
26 whether property is exempt from taxation under ORS chapter 307.

27 SECTION 50. The University of Oregon Board of Directors may, in its discretion, accept
28 financial assistance and grants, either in the form of money or labor, from the United States
29 or any of its agencies, subject to the terms and conditions thereof, regardless of any laws
30 of this state in conflict with the regulations of the federal government with respect thereto,
31 and may also accept from others any donation or grant of land or gift of money or other
32 valuable gift or thing, for any of the purposes contemplated by Article XI-F(1) and Article
33 XI-G of the Oregon Constitution and sections 39 to 49 of this 2011 Act. Unless enjoined by
34 the terms or conditions of any such gift or grant, the board may convert the same, or any
35 of them, into money, through sale or disposal thereof.

36 SECTION 51. (1) The State Board of Higher Education, in coordination with the Univer-
37 sity of Oregon, shall enact performance benchmarks for the university. The benchmarks
38 must reflect the educational outcomes that the State Board of Higher Education expects
39 from the university. The State Board of Higher Education may not prescribe how the
40 benchmarks are to be achieved. The president of the university and the University of Oregon
41 Board of Directors have exclusive jurisdiction and control over the means and methods of
42 achieving the performance benchmarks.

43 (2) The State Board of Higher Education shall assess the university's compliance with the
44 benchmarks established in subsection (1) of this section annually and shall issue a report as
45 to the university's achievements. The state board may recommend to the Legislative As-

1 sembly incentives to encourage compliance with the benchmarks or penalties for failure to
2 comply with one or more benchmarks.

3 (3) The university and the Oregon University System shall coordinate academic programs
4 so that they are integrated and complementary. To accomplish this purpose, university offi-
5 cers shall maintain a role in the appropriate committees of the State Board of Higher Edu-
6 cation and the Oregon University System. The State Board of Higher Education shall have
7 final authority over creation of new degree programs at the University of Oregon.

8 **SECTION 52.** The University of Oregon Board of Directors shall adopt a policy that pre-
9 scribes the requirements for a venture grant program and the requirements that a grant
10 applicant must meet in order to receive grant moneys from the university venture develop-
11 ment fund administered by the University of Oregon, including requirements:

12 (1) That a grant recipient remain within this state for at least five years following the
13 receipt of a grant or repay the grant plus interest;

14 (2) That the university report amounts of tax credit certificates issued by the university
15 and cease issuing certificates until the total amount owed to the General Fund by the uni-
16 versity at any one time under ORS 351.697 (6) does not exceed \$2.4 million; and

17 (3) That the university maintain records of income realized by the university as the re-
18 sult of grants made from the university venture development fund and records of amounts
19 paid to the General Fund.

20 **SECTION 53.** As used in sections 53 to 64 of this 2011 Act:

21 (1) "Former university" means the University of Oregon in its former status as a uni-
22 versity within the Oregon University System under ORS 352.002, as set forth in the 2009
23 Edition of the Oregon Revised Statutes.

24 (2) "University" means the University of Oregon public university established under sec-
25 tion 2 of this 2011 Act.

26 (3) "University board" means the University of Oregon Board of Directors established
27 under section 4 of this 2011 Act.

28 **SECTION 54.** (1) Pursuant to the provisions of ORS 236.605 to 236.640, and except as
29 otherwise expressly provided in sections 1 to 52 of this 2011 Act, all persons employed by the
30 University of Oregon on the effective date of this 2011 Act shall continue their employment
31 with the university and shall retain any seniority, contractual rights or tenure granted prior
32 to the effective date of this 2011 Act.

33 (2) Nothing in sections 1 to 52 of this 2011 Act shall affect the representation rights of
34 collective bargaining organizations that represent university employees. Nothing in sections
35 1 to 52 of this 2011 Act shall affect any term or condition of any collective bargaining
36 agreement in effect on the effective date of this 2011 Act.

37 **SECTION 55.** All of the duties, functions and powers of the former university are trans-
38 ferred to the university as if the university were a continuation of the former university and
39 not a new authority.

40 **SECTION 56.** (1) All records and property of the former university shall be considered
41 the records and property of the university.

42 (2) There are transferred to the University of Oregon Board of Directors title to and
43 possession of all the supplies, materials, equipment, records, books, papers and facilities of
44 the State Board of Higher Education pertaining to the former university.

45 (3) Title to real property acquired prior to the effective date of this 2011 Act utilized by

1 the former university or held or managed by the state for the benefit of the former univer-
2 sity shall be continuously held in the name of the State of Oregon, except that the university
3 has the exclusive care, custody and control of such real property and facilities.

4 (4) The University of Oregon Board of Directors may sell, convey or lease such property,
5 or any interest therein, as the board deems in the best interest of the university as provided
6 in section 13 of this 2011 Act.

7 **SECTION 57.** All unexpended moneys, including but not limited to General Fund appro-
8 priations, gifts, bequests, other funds, assessments, liability and worker's compensation re-
9 serves and premiums that are appropriated to, held, managed or invested by or on behalf of
10 or otherwise available to the former university or its president, for the purposes of any of
11 its duties, functions or powers transferred by sections 1 to 52 of this 2011 Act to the uni-
12 versity, are appropriated and transferred to the university.

13 **SECTION 58.** (1) Any proceeding, action, prosecution or other business or matter
14 undertaken or commenced before the effective date of this 2011 Act by the former university,
15 with respect to the duties, functions or powers transferred to the university by sections 1
16 to 52 of this 2011 Act and still pending on the effective date of this 2011 Act may be conducted
17 and completed by the university in the same manner, under the same terms and conditions
18 and with the same effect as though undertaken, conducted or completed by the former uni-
19 versity before the transfer.

20 (2) The transfer of duties, functions and powers to the University of Oregon Board of
21 Directors under sections 1 to 52 of this 2011 Act does not affect any action, suit, proceeding
22 or prosecution involving or with respect to such duties, functions and powers begun before
23 and pending at the time of the transfer, except that the university board shall be substituted
24 for the State Board of Higher Education in any such action, suit, proceeding or prosecution.

25 **SECTION 59.** Nothing in sections 1 to 52 of this 2011 Act relieves any person of any ob-
26 ligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture or other
27 liability, duty or obligation.

28 **SECTION 60.** The university is considered to be a continuation of the former university
29 with respect to its duties, functions and powers, and not a new authority for the purpose of
30 succession to all rights and obligations of the former university as constituted at the time
31 of such assignment or transfer, except as otherwise provided in sections 1 to 52 of this 2011
32 Act, with the same force and effect as if such duties, functions and powers had not been
33 assigned or transferred.

34 **SECTION 61.** (1) Whenever, in any law or resolution of the Legislative Assembly or in
35 any rule, document, record or proceeding authorized thereby, reference is made to the for-
36 mer university, or an employee of the former university, whose duties, functions or powers
37 are assigned or transferred by sections 1 to 52 of this 2011 Act, except as otherwise provided
38 by sections 1 to 52 of this 2011 Act, such reference is considered to describe the university
39 or employee of the university that, by sections 1 to 52 of this 2011 Act, is charged with car-
40 rying out such duties, functions and powers.

41 (2) The lawful rules of the former university with respect to duties, functions or powers
42 assigned or transferred by sections 1 to 52 of this 2011 Act continue in effect until superseded
43 or rescinded by the University of Oregon Board of Directors.

44 (3) Notwithstanding the transfer of duties, functions and powers by sections 1 to 52 of
45 this 2011 Act, the lawfully adopted rules of the State Board of Higher Education pertaining

1 to the former university in effect on the effective date of this 2011 Act continue in effect
2 until lawfully superseded or repealed by the University of Oregon Board of Directors. Refer-
3 ences in rules of the State Board of Higher Education to the board or an officer or employee
4 of the board are considered to be references to the University of Oregon Board of Directors.

5 **SECTION 62.** A transfer of duties, functions, powers, rights, records, property, employees
6 or moneys by sections 1 to 52 of this 2011 Act becomes operative on January 1, 2012. The
7 university shall exercise and perform such duties, functions, powers and rights, and shall
8 take charge of such records, property, employees and moneys.

9 **SECTION 63.** The rights and obligations of the State Board of Higher Education legally
10 incurred under contracts, leases and business transactions executed, entered into or begun
11 before the effective date of this 2011 Act pertaining to the former university are transferred
12 to the University of Oregon Board of Directors. For the purpose of succession to these rights
13 and obligations, the university board is considered to be a continuation of the State Board
14 of Higher Education and not a new authority, and the university board must exercise such
15 rights and fulfill such obligations as if they had not been transferred.

16 **SECTION 64.** For the purpose of administering and enforcing the duties, functions and
17 powers transferred by sections 1 to 52 of this 2011 Act and for the payment of the expenses
18 lawfully incurred by the State Board of Higher Education with respect to the administration
19 and enforcement of such duties, functions and powers pertaining to the former university,
20 the University of Oregon Board of Directors may expend the moneys that are authorized to
21 be expended by the State Board of Higher Education for administering and enforcing the
22 duties, functions and powers transferred by sections 1 to 52 of this 2011 Act and that are
23 unexpended on the effective date of this 2011 Act. Subject to section 37 of this 2011 Act, the
24 university board shall assume and pay all outstanding obligations lawfully incurred by the
25 State Board of Higher Education pertaining to the former university before the effective date
26 of this 2011 Act that are properly charged against amounts authorized by this section to be
27 expended by the university board.

28 **SECTION 65.** ORS 192.502, as amended by section 15, chapter 76, Oregon Laws 2010, is
29 amended to read:

30 192.502. The following public records are exempt from disclosure under ORS 192.410 to 192.505:

31 (1) Communications within a public body or between public bodies of an advisory nature to the
32 extent that they cover other than purely factual materials and are preliminary to any final agency
33 determination of policy or action. This exemption shall not apply unless the public body shows that
34 in the particular instance the public interest in encouraging frank communication between officials
35 and employees of public bodies clearly outweighs the public interest in disclosure.

36 (2) Information of a personal nature such as but not limited to that kept in a personal, medical
37 or similar file, if public disclosure would constitute an unreasonable invasion of privacy, unless the
38 public interest by clear and convincing evidence requires disclosure in the particular instance. The
39 party seeking disclosure shall have the burden of showing that public disclosure would not consti-
40 tute an unreasonable invasion of privacy.

41 (3) Public body employee or volunteer addresses, Social Security numbers, dates of birth and
42 telephone numbers contained in personnel records maintained by the public body that is the em-
43 ployer or the recipient of volunteer services. This exemption:

44 (a) Does not apply to the addresses, dates of birth and telephone numbers of employees or vol-
45 unteers who are elected officials, except that a judge or district attorney subject to election may

1 seek to exempt the judge's or district attorney's address or telephone number, or both, under the
2 terms of ORS 192.445;

3 (b) Does not apply to employees or volunteers to the extent that the party seeking disclosure
4 shows by clear and convincing evidence that the public interest requires disclosure in a particular
5 instance;

6 (c) Does not apply to a substitute teacher as defined in ORS 342.815 when requested by a pro-
7 fessional education association of which the substitute teacher may be a member; and

8 (d) Does not relieve a public employer of any duty under ORS 243.650 to 243.782.

9 (4) Information submitted to a public body in confidence and not otherwise required by law to
10 be submitted, where such information should reasonably be considered confidential, the public body
11 has obliged itself in good faith not to disclose the information, and when the public interest would
12 suffer by the disclosure.

13 (5) Information or records of the Department of Corrections, including the State Board of Parole
14 and Post-Prison Supervision, to the extent that disclosure would interfere with the rehabilitation of
15 a person in custody of the department or substantially prejudice or prevent the carrying out of the
16 functions of the department, if the public interest in confidentiality clearly outweighs the public in-
17 terest in disclosure.

18 (6) Records, reports and other information received or compiled by the Director of the Depart-
19 ment of Consumer and Business Services in the administration of ORS chapters 723 and 725 not
20 otherwise required by law to be made public, to the extent that the interests of lending institutions,
21 their officers, employees and customers in preserving the confidentiality of such information out-
22 weighs the public interest in disclosure.

23 (7) Reports made to or filed with the court under ORS 137.077 or 137.530.

24 (8) Any public records or information the disclosure of which is prohibited by federal law or
25 regulations.

26 (9)(a) Public records or information the disclosure of which is prohibited or restricted or other-
27 wise made confidential or privileged under Oregon law.

28 (b) Subject to ORS 192.423, paragraph (a) of this subsection does not apply to factual information
29 compiled in a public record when:

30 (A) The basis for the claim of exemption is ORS 40.225;

31 (B) The factual information is not prohibited from disclosure under any applicable state or fed-
32 eral law, regulation or court order and is not otherwise exempt from disclosure under ORS 192.410
33 to 192.505;

34 (C) The factual information was compiled by or at the direction of an attorney as part of an
35 investigation on behalf of the public body in response to information of possible wrongdoing by the
36 public body;

37 (D) The factual information was not compiled in preparation for litigation, arbitration or an
38 administrative proceeding that was reasonably likely to be initiated or that has been initiated by
39 or against the public body; and

40 (E) The holder of the privilege under ORS 40.225 has made or authorized a public statement
41 characterizing or partially disclosing the factual information compiled by or at the attorney's di-
42 rection.

43 (10) Public records or information described in this section, furnished by the public body ori-
44 ginally compiling, preparing or receiving them to any other public officer or public body in con-
45 nection with performance of the duties of the recipient, if the considerations originally giving rise

1 to the confidential or exempt nature of the public records or information remain applicable.

2 (11) Records of the Energy Facility Siting Council concerning the review or approval of security
3 programs pursuant to ORS 469.530.

4 (12) Employee and retiree address, telephone number and other nonfinancial membership records
5 and employee financial records maintained by the Public Employees Retirement System pursuant to
6 ORS chapters 238 and 238A.

7 (13) Records of or submitted to the State Treasurer, the Oregon Investment Council or the
8 agents of the treasurer or the council relating to active or proposed publicly traded investments
9 under ORS chapter 293, including but not limited to records regarding the acquisition, exchange or
10 liquidation of the investments. For the purposes of this subsection:

11 (a) The exemption does not apply to:

12 (A) Information in investment records solely related to the amount paid directly into an invest-
13 ment by, or returned from the investment directly to, the treasurer or council; or

14 (B) The identity of the entity to which the amount was paid directly or from which the amount
15 was received directly.

16 (b) An investment in a publicly traded investment is no longer active when acquisition, exchange
17 or liquidation of the investment has been concluded.

18 (14)(a) Records of or submitted to the State Treasurer, the Oregon Investment Council, the
19 Oregon Growth Account Board or the agents of the treasurer, council or board relating to actual
20 or proposed investments under ORS chapter 293 or 348 in a privately placed investment fund or a
21 private asset including but not limited to records regarding the solicitation, acquisition, deployment,
22 exchange or liquidation of the investments including but not limited to:

23 (A) Due diligence materials that are proprietary to an investment fund, to an asset ownership
24 or to their respective investment vehicles.

25 (B) Financial statements of an investment fund, an asset ownership or their respective invest-
26 ment vehicles.

27 (C) Meeting materials of an investment fund, an asset ownership or their respective investment
28 vehicles.

29 (D) Records containing information regarding the portfolio positions in which an investment
30 fund, an asset ownership or their respective investment vehicles invest.

31 (E) Capital call and distribution notices of an investment fund, an asset ownership or their re-
32 spective investment vehicles.

33 (F) Investment agreements and related documents.

34 (b) The exemption under this subsection does not apply to:

35 (A) The name, address and vintage year of each privately placed investment fund.

36 (B) The dollar amount of the commitment made to each privately placed investment fund since
37 inception of the fund.

38 (C) The dollar amount of cash contributions made to each privately placed investment fund since
39 inception of the fund.

40 (D) The dollar amount, on a fiscal year-end basis, of cash distributions received by the State
41 Treasurer, the Oregon Investment Council, the Oregon Growth Account Board or the agents of the
42 treasurer, council or board from each privately placed investment fund.

43 (E) The dollar amount, on a fiscal year-end basis, of the remaining value of assets in a privately
44 placed investment fund attributable to an investment by the State Treasurer, the Oregon Investment
45 Council, the Oregon Growth Account Board or the agents of the treasurer, council or board.

1 (F) The net internal rate of return of each privately placed investment fund since inception of
2 the fund.

3 (G) The investment multiple of each privately placed investment fund since inception of the fund.

4 (H) The dollar amount of the total management fees and costs paid on an annual fiscal year-end
5 basis to each privately placed investment fund.

6 (I) The dollar amount of cash profit received from each privately placed investment fund on a
7 fiscal year-end basis.

8 (15) The monthly reports prepared and submitted under ORS 293.761 and 293.766 concerning the
9 Public Employees Retirement Fund and the Industrial Accident Fund may be uniformly treated as
10 exempt from disclosure for a period of up to 90 days after the end of the calendar quarter.

11 (16) Reports of unclaimed property filed by the holders of such property to the extent permitted
12 by ORS 98.352.

13 (17)(a) The following records, communications and information submitted to the Oregon Business
14 Development Commission, the Oregon Business Development Department, the State Department of
15 Agriculture, the Oregon Growth Account Board, the Port of Portland or other ports, as defined in
16 ORS 777.005, by applicants for investment funds, loans or services including, but not limited to,
17 those described in ORS 285A.224:

18 (A) Personal financial statements.

19 (B) Financial statements of applicants.

20 (C) Customer lists.

21 (D) Information of an applicant pertaining to litigation to which the applicant is a party if the
22 complaint has been filed, or if the complaint has not been filed, if the applicant shows that such
23 litigation is reasonably likely to occur; this exemption does not apply to litigation which has been
24 concluded, and nothing in this subparagraph shall limit any right or opportunity granted by discov-
25 ery or deposition statutes to a party to litigation or potential litigation.

26 (E) Production, sales and cost data.

27 (F) Marketing strategy information that relates to applicant's plan to address specific markets
28 and applicant's strategy regarding specific competitors.

29 (b) The following records, communications and information submitted to the State Department
30 of Energy by applicants for tax credits:

31 (A) Personal financial statements.

32 (B) Financial statements of applicants.

33 (C) Customer lists.

34 (D) Information of an applicant pertaining to litigation to which the applicant is a party if the
35 complaint has been filed, or if the complaint has not been filed, if the applicant shows that such
36 litigation is reasonably likely to occur; this exemption does not apply to litigation which has been
37 concluded, and nothing in this subparagraph shall limit any right or opportunity granted by discov-
38 ery or deposition statutes to a party to litigation or potential litigation.

39 (E) Production, sales and cost data.

40 (F) Marketing strategy information that relates to applicant's plan to address specific markets
41 and applicant's strategy regarding specific competitors.

42 (18) Records, reports or returns submitted by private concerns or enterprises required by law
43 to be submitted to or inspected by a governmental body to allow it to determine the amount of any
44 transient lodging tax payable and the amounts of such tax payable or paid, to the extent that such
45 information is in a form which would permit identification of the individual concern or enterprise.

1 Nothing in this subsection shall limit the use which can be made of such information for regulatory
2 purposes or its admissibility in any enforcement proceedings. The public body shall notify the tax-
3 payer of the delinquency immediately by certified mail. However, in the event that the payment or
4 delivery of transient lodging taxes otherwise due to a public body is delinquent by over 60 days, the
5 public body shall disclose, upon the request of any person, the following information:

6 (a) The identity of the individual concern or enterprise that is delinquent over 60 days in the
7 payment or delivery of the taxes.

8 (b) The period for which the taxes are delinquent.

9 (c) The actual, or estimated, amount of the delinquency.

10 (19) All information supplied by a person under ORS 151.485 for the purpose of requesting ap-
11 pointed counsel, and all information supplied to the court from whatever source for the purpose of
12 verifying the financial eligibility of a person pursuant to ORS 151.485.

13 (20) Workers' compensation claim records of the Department of Consumer and Business Services,
14 except in accordance with rules adopted by the Director of the Department of Consumer and Busi-
15 ness Services, in any of the following circumstances:

16 (a) When necessary for insurers, self-insured employers and third party claim administrators to
17 process workers' compensation claims.

18 (b) When necessary for the director, other governmental agencies of this state or the United
19 States to carry out their duties, functions or powers.

- 32 (b) Identify those areas of structural or operational vulnerability that would permit unlawful
33 disruption to, or interference with, services; or
- 34 (c) Disrupt, interfere with or gain unauthorized access to public funds or to information pro-
35 cessing, communication or telecommunication systems, including the information contained in the
36 systems, that are used or operated by a public body.

37 (23) Records or information that would reveal or otherwise identify security measures, or
38 weaknesses or potential weaknesses in security measures, taken or recommended to be taken to
39 protect:

- 40 (a) An individual;
- 41 (b) Buildings or other property;
- 42 (c) Information processing, communication or telecommunication systems, including the infor-
43 mation contained in the systems; or
- 44 (d) Those operations of the Oregon State Lottery the security of which are subject to study and
45 evaluation under ORS 461.180 (6).

1 (24) Personal information held by or under the direction of officials of the Oregon Health and
2 Science University, **the University of Oregon** or the Oregon University System about a person who
3 has or who is interested in donating money or property to the university, the system or a state in-
4 stitution of higher education, if the information is related to the family of the person, personal assets
5 of the person or is incidental information not related to the donation.

6 (25) The home address, professional address and telephone number of a person who has or who
7 is interested in donating money or property to **the University of Oregon** or the Oregon University
8 System.

9 (26) Records of the name and address of a person who files a report with or pays an assessment
10 to a commodity commission established under ORS 576.051 to 576.455, the Oregon Beef Council
11 created under ORS 577.210 or the Oregon Wheat Commission created under ORS 578.030.

12 (27) Information provided to, obtained by or used by a public body to authorize, originate, re-
13 ceive or authenticate a transfer of funds, including but not limited to a credit card number, payment
14 card expiration date, password, financial institution account number and financial institution routing
15 number.

16 (28) Social Security numbers as provided in ORS 107.840.

17 (29) The electronic mail address of a student who attends a state institution of higher education
18 listed in ORS 352.002, **the University of Oregon** or Oregon Health and Science University.

19 (30) If requested by a public safety officer, as defined in ORS 181.610:

20 (a) The home address and home telephone number of the public safety officer contained in the
21 voter registration records for the public safety officer.

22 (b) The home address and home telephone number of the public safety officer contained in re-
23 cords of the Department of Public Safety Standards and Training.

24 (c) The name of the public safety officer contained in county real property assessment or taxa-
25 tion records. This exemption:

26 (A) Applies only to the name of the public safety officer and any other owner of the property
27 in connection with a specific property identified by the officer in a request for exemption from dis-
28 closure;

29 (B) Applies only to records that may be made immediately available to the public upon request
30 in person, by telephone or using the Internet;

31 (C) Applies until the public safety officer requests termination of the exemption;

32 (D) Does not apply to disclosure of records among public bodies as defined in ORS 174.109 for
33 governmental purposes; and

34 (E) May not result in liability for the county if the name of the public safety officer is disclosed
35 after a request for exemption from disclosure is made under this subsection.

36 (31) Unless the public records request is made by a financial institution, as defined in ORS
37 706.008, consumer finance company licensed under ORS chapter 725, mortgage banker or mortgage
38 broker licensed under ORS 86A.095 to 86A.198, 86A.990 and 86A.992 and ORS chapter 59, or title
39 company for business purposes, records described in paragraph (a) of this subsection, if the ex-
40 emption from disclosure of the records is sought by an individual described in paragraph (b) of this
41 subsection using the procedure described in paragraph (c) of this subsection:

42 (a) The home address, home or cellular telephone number or personal electronic mail address
43 contained in the records of any public body that has received the request that is set forth in:

44 (A) A warranty deed, deed of trust, mortgage, lien, deed of reconveyance, release, satisfaction,
45 substitution of trustee, easement, dog license, marriage license or military discharge record that is

1 in the possession of the county clerk; or

2 (B) Any public record of a public body other than the county clerk.

3 (b) The individual claiming the exemption from disclosure must be a district attorney, a deputy
4 district attorney, the Attorney General or an assistant attorney general, the United States Attorney
5 for the District of Oregon or an assistant United States attorney for the District of Oregon, a city
6 attorney who engages in the prosecution of criminal matters or a deputy city attorney who engages
7 in the prosecution of criminal matters.

8 (c) The individual claiming the exemption from disclosure must do so by filing the claim in
9 writing with the public body for which the exemption from disclosure is being claimed on a form
10 prescribed by the public body. Unless the claim is filed with the county clerk, the claim form shall
11 list the public records in the possession of the public body to which the exemption applies. The ex-
12 emption applies until the individual claiming the exemption requests termination of the exemption

14 (32) Land management plans required for voluntary stewardship agreements entered into under

16 (33) Sensitive business records or financial or commercial information of the State Accident In-
17 surance Fund Corporation that is not customarily provided to business competitors. This exemption
18 does not:

19 (a) Apply to the formulas for determining dividends to be paid to employers insured by the State
20 Accident Insurance Fund Corporation;

21 (b) Apply to contracts for advertising, public relations or lobbying services or to documents re-
22 lated to the formation of such contracts;

23 (c) Apply to group insurance contracts or to documents relating to the formation of such con-
24 tracts, except that employer account records shall remain exempt from disclosure as provided in
25 ORS 192.502 (35); or

26 (d) Provide the basis for opposing the discovery of documents in litigation pursuant to the ap-
27 plicable rules of civil procedure.

28 (34) Records of the Department of Public Safety Standards and Training relating to investi-
29 gations conducted under ORS 181.662 or 181.878 (6), until the department issues the report described
30 in ORS 181.662 or 181.878.

31 (35) A medical examiner's report, autopsy report or laboratory test report ordered by a medical
32 examiner under ORS 146.117.

33 **SECTION 82.** ORS 238.005, as amended by section 8, chapter 1, Oregon Laws 2010, is amended
34 to read:

35 238.005. For purposes of this chapter:

36 (1) "Annuity" means payments for life derived from contributions made by a member as provided
37 in this chapter.

38 (2) "Board" means the Public Employees Retirement Board.

39 (3) "Calendar year" means 12 calendar months commencing on January 1 and ending on De-
40 cember 31 following.

41 (4) "Continuous service" means service not interrupted for more than five years, except that
42 such continuous service shall be computed without regard to interruptions in the case of:

43 (a) An employee who had returned to the service of the employer as of January 1, 1945, and
44 who remained in that employment until having established membership in the Public Employees
45 Retirement System.

1 (b) An employee who was in the armed services on January 1, 1945, and returned to the service
2 of the employer within one year of the date of being otherwise than dishonorably discharged and
3 remained in that employment until having established membership in the Public Employees Retirement
4 System.

5 (5) "Creditable service" means any period of time during which an active member is being paid
6 a salary by a participating public employer and for which benefits under this chapter are funded by
7 employer contributions and earnings on the fund. For purposes of computing years of "creditable
8 service," full months and major fractions of a month shall be considered to be one-twelfth of a year
9 and shall be added to all full years. "Creditable service" includes all retirement credit received by
10 a member.

11 (6) "Earliest service retirement age" means the age attained by a member when the member
12 could first make application for retirement under the provisions of ORS 238.280.

13 (7) "Employee" includes, in addition to employees, public officers, but does not include:

14 (a) Persons engaged as independent contractors.

15 (b) Seasonal, emergency or casual workers whose periods of employment with any public em-
16 ployer or public employers do not total 600 hours in any calendar year.

17 (c) Persons, other than workers in the Oregon Industries for the Blind under ORS 346.190, pro-
18 vided sheltered employment or made-work by a public employer in an employment or industries
19 program maintained for the benefit of such persons.

20 (d) Persons employed and paid from federal funds received under the Emergency Job and Un-
21 employment Assistance Act of 1974 (Public Law 93-567) or any other federal program intended pri-
22 marily to alleviate unemployment. However, any such person shall be considered an "employee" if
23 not otherwise excluded by paragraphs (a) to (c) of this subsection and the public employer elects to
24 have the person so considered by an irrevocable written notice to the board.

25 (e) Persons who are employees of a railroad, as defined in ORS 824.020, and who, as such em-
26 ployees, are included in a retirement plan under federal railroad retirement statutes. This paragraph
27 shall be deemed to have been in effect since the inception of the system.

28 (8) "Final average salary" means whichever of the following is greater:

29 (a) The average salary per calendar year paid by one or more participating public employers to
30 an employee who is an active member of the system in three of the calendar years of membership
31 before the effective date of retirement of the employee, in which three years the employee was paid
32 the highest salary. The three calendar years in which the employee was paid the largest total salary
33 may include calendar years in which the employee was employed for less than a full calendar year.
34 If the number of calendar years of active membership before the effective date of retirement of the
35 employee is three or fewer, the final average salary for the employee is the average salary per cal-
36 endar year paid by one or more participating public employers to the employee in all of those years,
37 without regard to whether the employee was employed for the full calendar year.

38 (b) One-third of the total salary paid by a participating public employer to an employee who is
39 an active member of the system in the last 36 calendar months of active membership before the ef-
40 fective date of retirement of the employee.

41 (9) "Firefighter" does not include a volunteer firefighter, but does include:

42 (a) The State Fire Marshal, the chief deputy fire marshal and deputy state fire marshals; and

43 (b) An employee of the State Forestry Department who is certified by the State Forester as a
44 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
45 fires as described in ORS 477.064.

1 (10) "Fiscal year" means 12 calendar months commencing on July 1 and ending on June 30 fol-
2 lowing.

3 (11) "Fund" means the Public Employees Retirement Fund.

4 (12)(a) "Member" means a person who has established membership in the system and whose
5 membership has not been terminated as described in ORS 238.095. "Member" includes active, inac-
6 tive and retired members.

7 (b) "Active member" means a member who is presently employed by a participating public em-
8 ployer in a qualifying position and who has completed the six-month period of service required by
9 ORS 238.015.

10 (c) "Inactive member" means a member who is not employed in a qualifying position, whose
11 membership has not been terminated in the manner described by ORS 238.095, and who is not retired
12 for service or disability.

13 (d) "Retired member" means a member who is retired for service or disability.

14 (13)(a) "Member account" means the regular account and the variable account.

15 (b) "Regular account" means the account established for each active and inactive member under
16 ORS 238.250.

17 (c) "Variable account" means the account established for a member who participates in the
18 Variable Annuity Account under ORS 238.260.

19 (14) "Normal retirement age" means:

20 (a) For a person who establishes membership in the system before January 1, 1996, as described
21 in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or firefighter
22 or 58 years of age if the employee retires at that age as other than a police officer or firefighter.

23 (b) For a person who establishes membership in the system on or after January 1, 1996, as de-
24 scribed in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or
25 firefighter or 60 years of age if the employee retires at that age as other than a police officer or
26 firefighter.

27 (15) "Pension" means annual payments for life derived from contributions by one or more public
28 employers.

29 (16) "Police officer" includes:

30 (a) Employees of institutions defined in ORS 421.005 as Department of Corrections institutions
31 whose duties, as assigned by the Director of the Department of Corrections, include the custody of
32 persons committed to the custody of or transferred to the Department of Corrections and employees
33 of the Department of Corrections who were classified as police officers on or before July 27, 1989,
34 whether or not such classification was authorized by law.

35 (b) Employees of the Department of State Police who are classified as police officers by the
36 Superintendent of State Police.

37 (c) Employees of the Oregon Liquor Control Commission who are classified as enforcement of-
38 ficers by the administrator of the commission.

39 (d) Sheriffs and those deputy sheriffs or other employees of a sheriff whose duties, as classified
40 by the sheriff, are the regular duties of police officers or corrections officers.

41 (e) Police chiefs and police personnel of a city who are classified as police officers by the
42 council or other governing body of the city.

43 (f) Parole and probation officers employed by the Department of Corrections, parole and pro-
44 bation officers who are transferred to county employment under ORS 423.549 and adult parole and
45 probation officers, as defined in ORS 181.610, who are classified as police officers for the purposes

1 of this chapter by the county governing body. If a county classifies adult parole and probation offi-
2 cers as police officers for the purposes of this chapter, and the employees so classified are repres-
3 ented by a labor organization, any proposal by the county to change that classification or to cease
4 to classify adult parole and probation officers as police officers for the purposes of this chapter is
5 a mandatory subject of bargaining.

6 (g) Police officers appointed under ORS 276.021 or 276.023.

7 (h) Employees of the Port of Portland who are classified as airport police by the Board of
8 Commissioners of the Port of Portland.

9 (i) Employees of the State Department of Agriculture who are classified as livestock police of-
10 ficers by the Director of Agriculture.

11 (j) Employees of the Department of Public Safety Standards and Training who are classified by
12 the department as other than secretarial or clerical personnel.

13 (k) Investigators of the Criminal Justice Division of the Department of Justice.

14 (L) Corrections officers as defined in ORS 181.610.

15 (m) Employees of the Oregon State Lottery Commission who are classified by the Director of the
16 Oregon State Lottery as enforcement agents pursuant to ORS 461.110.

17 (n) The Director of the Department of Corrections.

18 (o) An employee who for seven consecutive years has been classified as a police officer as de-
19 fined by this section, and who is employed or transferred by the Department of Corrections to fill
20 a position designated by the Director of the Department of Corrections as being eligible for police
21 officer status.

22 (p) An employee of the Department of Corrections classified as a police officer on or prior to
23 July 27, 1989, whether or not that classification was authorized by law, as long as the employee
24 remains in the position held on July 27, 1989. The initial classification of an employee under a sys-
25 tem implemented pursuant to ORS 240.190 does not affect police officer status.

26 (q) Employees of a school district who are appointed and duly sworn members of a law
27 enforcement agency of the district as provided in ORS 332.531 or otherwise employed full-time as
28 police officers commissioned by the district.

29 (r) Employees at youth correction facilities and juvenile detention facilities under ORS 419A.050,
30 419A.052 and 420.005 to 420.915 who are required to hold valid Oregon teaching licenses and who
31 have supervisory, control or teaching responsibilities over juveniles committed to the custody of the
32 Department of Corrections or the Oregon Youth Authority.

33 (s) Employees at youth correction facilities as defined in ORS 420.005 whose primary job de-
34 scription involves the custody, control, treatment, investigation or supervision of juveniles placed
35 in such facilities.

36 (t) Employees of the Oregon Youth Authority who are classified as juvenile parole and probation
37 officers.

38 (17) "Public employer" means the state, one of its agencies, any city, county, or municipal or
39 public corporation, **any public university**, any political subdivision of the state or any
40 instrumentality thereof, or an agency created by one or more such governmental organizations to
41 provide governmental services. For purposes of this chapter, such agency created by one or more
42 governmental organizations is a governmental instrumentality and a legal entity with power to enter
43 into contracts, hold property and sue and be sued.

44 (18) "Prior service credit" means credit provided under ORS 238.442 or under ORS 238.225 (2)
45 to (6) (1999 Edition).

1 (19) "Qualifying position" means one or more jobs with one or more participating public em-
 2 ployers in which an employee performs 600 or more hours of service in a calendar year, excluding
 3 any service in a job for which a participating public employer does not provide benefits under this
 4 chapter pursuant to an application made under ORS 238.035.

5 (20) "Retirement credit" means a period of time that is treated as creditable service for the
 6 purposes of this chapter.

7 (21)(a) "Salary" means the remuneration paid an employee in cash out of the funds of a public
 8 employer in return for services to the employer, plus the monetary value, as determined by the
 9 Public Employees Retirement Board, of whatever living quarters, board, lodging, fuel, laundry and
 10 other advantages the employer furnishes the employee in return for services.

11 (b) "Salary" includes but is not limited to:

12 (A) Payments of employee and employer money into a deferred compensation plan, which are
 13 deemed salary paid in each month of deferral;

14 (B) The amount of participation in a tax-sheltered or deferred annuity, which is deemed salary
 15 paid in each month of participation;

16 (C) Retroactive payments described in section 7, chapter 1, Oregon Laws 2010; and

17 (D) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
 18 652.190.

19 (c) "Salary" or "other advantages" does not include:

20 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
 21 employer;

22 (B) Payments for insurance coverage by an employer on behalf of employee or employee and
 23 dependents, for which the employee has no cash option;

24 (C) Payments made on account of an employee's death;

25 (D) Any lump sum payment for accumulated unused sick leave;

26 (E) Any accelerated payment of an employment contract for a future period or an advance
 27 against future wages;

28 (F) Any retirement incentive, retirement severance pay, retirement bonus or retirement
 29 gratuitous payment;

30 (G) Payments for periods of leave of absence after the date the employer and employee have
 31 agreed that no future services qualifying pursuant to ORS 238.015 (3) will be performed, except for
 32 sick leave and vacation;

33 (H) Payments for instructional services rendered to institutions of the Oregon University
 34 System, **the University of Oregon** or the Oregon Health and Science University when such services
 35 are in excess of full-time employment subject to this chapter. A person employed under a contract
 36 for less than 12 months is subject to this subparagraph only for the months to which the contract
 37 pertains; or

38 (I) Payments made by an employer for insurance coverage provided to a domestic partner of an
 39 employee.

40 (22) "School year" means the period beginning July 1 and ending June 30 next following.

41 (23) "System" means the Public Employees Retirement System.

42 (24) "Vested" means being an active member of the system in each of five calendar years.

43 (25) "Volunteer firefighter" means a firefighter whose position normally requires less than 600
 44 hours of service per year.

45 **SECTION 83.** ORS 238.200 is amended to read:

1 238.200. (1)(a) An active member of the Public Employees Retirement System shall contribute to
2 the Public Employees Retirement Fund and there shall be withheld from salary of the member six
3 percent of that salary as an employee contribution.

4 (b) Notwithstanding paragraph (a) of this subsection, an employee who is an active member of
5 the system on August 21, 1981, shall contribute to the fund and there shall be withheld from salary
6 of the member, as long as the employee continues to be an active member of the system, four percent
7 of that salary if the salary for a month is less than \$500, or five percent of that salary if the salary

31 system shall receive a service retirement allowance which shall consist of the following annuity and

33 (1) A refund annuity which shall be the actuarial equivalent of accumulated contributions, if
34 any, by the member and interest thereon credited at the time of retirement, which annuity shall
35 provide an allowance payable during the life of the member and at death a lump sum equal in
36 amount to the difference between accumulated contributions at the time of retirement and the sum

4 (A) For service as a police officer or firefighter, two percent of final average salary multiplied
5 by the number of years of membership in the system as a police officer or firefighter before the ef-

12 (A) For a member who first establishes membership in the system before July 1, 2003, the
13 actuarial equivalent of the annuity provided by the accumulated contributions of the member. A
14 person establishes membership in the system before July 1, 2003, for the purposes of this subpara-
15 graph if:

16 (i) The person is a member of the system, or a judge member of the system, on the day imme-
17 diately before July 1, 2003; or

18 (ii) The person performed any period of service for a participating public employer before July
19 1, 2003, that is credited to the six-month period of employment required of an employee under ORS
20 238.015 before an employee may become a member of the system.

21 (B) For a member who made contributions before August 21, 1981, the equivalent of a pension
22 computed pursuant to this subsection as it existed immediately before that date.

23 (c) As used in this subsection, "number of years of membership" means the number of full years
24 of creditable service plus any remaining fraction of a year of creditable service. Except as other-
25 wise provided in this paragraph, in determining a remaining fraction a full month shall be consid-
26 ered as one-twelfth of a year and a major fraction of a month shall be considered as a full month.
27 Membership of a school district employee, an employee of the State Board of Higher Education **or**
28 **employee of the University of Oregon** engaged in teaching or other school activity at an institu-

43 (3) An additional life pension (nonrefund) for prior service credit, including military service,

45 in this chapter, which pension shall be provided by the contributions of the employer.

1 **SECTION 85.** ORS 238.350 is amended to read:

2 238.350. (1)(a) Upon the request by a public employer that its employees be compensated for
3 accumulated unused sick leave with pay in the form of increased retirement benefits upon service
4 or disability retirement, the board shall establish a procedure for adding to the gross amount of
5 salary used in determining final average salary the monetary value of one-half of the accumulated
6 unused sick leave with pay of each retiring employee of the requesting public employer and shall
7 establish benefits of the retiring employee on the basis of a final average salary reflecting that ad-
8 dition.

9 (b) For employees of a common school district, a union high school district, an education service
10 district or a community college, or employees of the State Board of Higher Education **or the Uni-**
11 **versity of Oregon** engaged in teaching or other school activity at an institution of higher educa-
12 tion, or employees of the school operated under ORS 346.010 engaged in teaching or other school
13 activity, who are employed under contract for a period of less than 12 consecutive months and who
14 are entitled to sick leave with pay of less than 96 hours for a year, each hour of accumulated unused
15 sick leave with pay shall be valued on the basis of the actual number of contract hours of employ-
16 ment during the last year of contributing membership of an employee before retiring and the salary
17 of the employee during the same period. This paragraph does not apply to any employee who is
18 employed under contract for 12 consecutive months in any of the three or less years used in deter-
19 mining the final average salary of the employee.

20 (c) For the purpose of this subsection, accumulated unused sick leave with pay includes unused
21 sick leave with pay accumulated by an active member of the system while in the service of any
22 public employer participating in the system that has the request described in paragraph (a) of this
23 subsection in effect at the time of the member's separation from the service of the employer, whether
24 that employer is or is not the employer of the member at the time of the member's retirement.

25 (d) The board shall establish rules requiring all public employers participating in the system to
26 transmit to the board reports of unused sick leave with pay accumulated by their employees who
27 are members of the system and to provide timely notification to each of those employees of unused
28 sick leave with pay accumulated by the employee and reported to the board.

29 (2) Accumulated unused sick leave with pay may be considered for the purpose of subsection (1)
30 of this section only in accordance with the following requirements:

31 (a) Sick leave not credited at the rate actually provided by the public employer may not be
32 considered. The amount of sick leave exceeding an amount credited at the lowest rate in effect for
33 any employee of the public employer who is normally entitled to sick leave, and in any event ex-
34 ceeding an amount credited at a rate of eight hours for each full month worked, may not be con-
35 sidered.

36 (b) Sick leave credited for periods when an employee was absent from employment on sabbatical
37 leave, educational leave or any leave without pay may not be considered.

38 (c) Any period during which an employee was absent from employment for illness or injury that
39 was charged against sick leave not qualified for consideration shall be deducted from sick leave

41 (d) Sick leave for any period for which the public employer provides no sick leave with pay for
42 its employees may not be considered.

43 (e) Sick leave accumulated on and after July 1, 1973, may be considered only to the extent it is
44 supported by records of accumulation and use pursuant to a plan adopted formally by the public
45 employer.

1 (f) Accumulated unused sick leave for periods before July 1, 1973, may be considered as follows:

2 (A) If any department, bureau or other organizational unit of a public employer maintained
3 formal records of accumulation and use even though the public employer did not require that those
4 records be maintained, the accumulated unused sick leave shall be considered according to those
5 records.

6 (B) Where the public employer provided sick leave before July 1, 1973, but formal records of
7 accumulation and use were not required or if required, are unavailable or incomplete, or the sick
8 leave was subject to administrative limitations on total accumulation or transfer between public
9 employers, accumulated unused sick leave for periods before July 1, 1973, may be considered as
10 equal to 2.675 hours for each full month worked or an amount per month equal to the average
11 monthly accumulation by an employee during the period beginning July 1, 1973, and ending at the
12 time of retirement, whichever amount is greater, but reduced by the amount of any accumulated
13 unused sick leave credited to the employee on July 1, 1973.

14 (g) The written certification of a member or former member of the Legislative Assembly shall
15 constitute a formal record of accumulation and use in determining the amount of accumulated un-
16 used sick leave of an employee of the Legislative Assembly, either of its houses or any of its com-
17 mittees or officers for periods of employment before July 1, 1981. Sick leave accumulated on and
18 after July 1, 1981, by employees of the Legislative Assembly, either of its houses or any of its com-
19 mittees or officers may be considered only to the extent it is supported by records of accumulation
20 and use maintained by the Legislative Administration Committee, or any statutory, standing, special
21 or interim committee of the Legislative Assembly or either house thereof, or any constitutional or
22 statutory office of the Legislative Assembly or either house thereof, pursuant to a plan adopted
23 formally by the committee or officer.

24 (3)(a) As used in this subsection, "legislative employee" means any person employed by the
25 Legislative Assembly, either of its houses or any of its committees or officers, but does not include
26 a regular employee of a statutory committee or statutory office of the Legislative Assembly de-

28 (b) Upon the request of a retiring legislative employee who is a member of the system, and the
29 request of the public employer of the legislative employee, that the legislative employee be com-
30 pensated for accumulated unused vacation with pay for periods of legislative employment in the form

32 gross amount of salary used in determining final average salary of the legislative employee the
33 monetary value of one-half of the accumulated unused vacation with pay of the legislative employee
34 and shall establish the benefits of the legislative employee on the basis of a final average salary

36 (c) Accumulated unused vacation with pay may be considered for the purposes of paragraph (b)
37 of this subsection only in accordance with the following requirements:

38 (A) Vacation not credited at the rate actually provided by the public employer may not be
39 considered.

40 (B) Amounts of vacation exceeding amounts creditable to employees in the classified service of
41 the state service pursuant to ORS 240.515 (1), and rules adopted pursuant thereto, in effect on June
42 30, 1981, shall not be considered.

43 (C) Vacation accumulated before, on and after July 1, 1981, may be considered only to the extent
44 it is supported by records of accumulation and use pursuant to a plan adopted formally by the public
45 employer. However, the written certification of a member or former member of the Legislative As-

1 sembly shall constitute a formal record of accumulation and use in determining the amount of ac-
 2 cumulated unused vacation of a legislative employee for periods of legislative employment before
 3 July 1, 1981.

4 (4) Employers with plans providing payments on account of sickness in lieu of sick leave with
 5 pay may request the board to consider the monetary value of accumulated unused payments on ac-
 6 count of sickness as if such payments were an equivalent amount of accumulated unused sick leave
 7 with pay under the same terms and conditions specified in subsections (1) and (2) of this section.

2 (6) "Fund" means the Public Employees Retirement Fund.

3 (7)(a) "Hour of service" means:

4 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
5 by a participating public employer for performance of duties in a qualifying position; and

6 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
7 during which an employee does not perform duties but for which the employee is directly or indi-

10 (G) The amount of an employee contribution to the individual account program that is not paid
11 by the employer under ORS 238A.335.

12 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
13 652.190.

14 (c) "Salary" does not include the following amounts:

15 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
16 employer.

17 (B) Payments made on account of an employee's death.

18 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
19 leave.

20 (D) Any severance payment, accelerated payment of an employment contract for a future period
21 or advance against future wages.

43 (a) Is a passenger vehicle with a passenger seating capacity that does not exceed five;

44 (b) Carries passengers for hire where the destination and route traveled may be controlled by
45 a passenger and the fare is calculated on the basis of any combination of an initial fee, distance

1 traveled or waiting time; and

2 (c) Is transporting persons or property, or both, between points in Oregon.

3 (3) Vehicles being used for the transportation of property by private carrier by means of a single
4 vehicle or combination of vehicles with a combined weight that does not exceed 8,000 pounds.

5 (4) Vehicles being used in operating implements of husbandry.

6 (5) Vehicles being used as a hearse or ambulance.

7 (6) Vehicles being used over any private road or thoroughfare.

8 (7) Vehicles being used on any road, thoroughfare or property, other than a state highway,
9 county road or city street, for the removal of forest products as defined in ORS 321.005, or the
10 product of forest products converted to a form other than logs at or near the harvesting site, or
11 when used for the construction or maintenance of the road, thoroughfare or property, pursuant to
12 a written agreement or permit authorizing the use, construction or maintenance of the road,
13 thoroughfare or property, with:

14 (a) An agency of the United States;

15 (b) The State Board of Forestry;

16 (c) The State Forester; or

17 (d) A licensee of an agency named in this subsection.

18 (8) Vehicles being used on any county road for the removal of forest products as defined in ORS
19 321.005, or the products of forest products converted to a form other than logs at or near the har-
20 vesting site, if:

21 (a) The use is pursuant to a written agreement entered into with the State Board of Forestry,
22 the State Forester or an agency of the United States, authorizing the owner of the motor vehicle
23 to use the road and requiring the owner to pay for or to perform the construction or maintenance
24 of the county road, including any operator of a motor vehicle retained to transport logs, poles and
25 piling for the owners who are exempt under this section;

26 (b) The board, officer or agency that entered into the agreement or granted the permit, by con-
27 tract with the county court or board of county commissioners, has assumed the responsibility for the
28 construction or maintenance of the county road; and

29 (c) Copies of the agreements or permits required by this subsection are filed with the Director
30 of Transportation.

31 (9) Vehicles being used in the transportation of persons for hire if the operation:

32 (a) Is performed by a nonprofit entity;

33 (b) Is not in competition with a regular route full-service scheduled carrier of persons that is
34 subject to the provisions of this chapter or a service provided by a mass transit district formed un-
35 der ORS chapter 267;

36 (c) Is performed by use of vehicles operating in compliance with ORS 820.020 to 820.070; and

37 (d) Is approved by the Department of Transportation as complying with paragraphs (a) to (c) of
38 this subsection.

39 (10) Vehicles being used in transporting persons with disabilities, with or without their super-
40 visors or assistants, to or from rehabilitation facilities or child care services if the motor vehicle is
41 a passenger motor vehicle with a seating capacity of not more than 12 passengers. The exemption
42 provided by this subsection applies only when the motor vehicle is operated by or under contract
43 with any person responsible for the administration of rehabilitation facilities as defined in ORS
44 344.710 to 344.730 or child care services provided by a facility licensed under ORS 657A.030 and
45 657A.250 to 657A.450.

1 (11) Vehicles owned or operated by the United States or by any governmental jurisdiction within
2 the United States except when owned or operated as a carrier of property for hire.

3 (12) Vehicles owned or operated by a mass transit district created under ORS chapter 267.

4 (13) Vehicles owned or operated by, or under contract with, a person responsible for the con-
5 struction or reconstruction of a highway under contract with the Department of Transportation or
6 with an agency of the United States when operated within the immediate construction project as
7 described in the governmental agency contract during the construction period.

8 (14) Vehicles owned or operated by, or under contract with, a charitable organization when ex-
9 clusively engaged in performing transportation, either one way or round trip, necessary to the op-
10 eration of the charitable organization. As used in this subsection, "charitable organization" means
11 an organization that has no capital stock and no provision for making dividends or profits, but de-
12 rives its funds principally from public and private charity and holds them in trust for the promotion
13 of the welfare of others and not for profit. Any organization claiming an exemption under this sub-
14 section shall file an affidavit with the department stating that it is organized and operated in ac-
15 cordance with the requirements of this subsection.

16 (15) Vehicles with a maximum speed that does not exceed 35 miles per hour that are designed
17 for off-road use and that are operated on the public highways in any one calendar year a number
18 of miles that does not exceed 15 percent of the total number of miles the vehicle is operated for that
19 calendar year.

20 (16) Passenger vehicles with a passenger seating capacity that does not exceed five when used
21 in the transportation of new telephone books.

22 (17) A vehicle that is used in a limousine service operation in which the destination and route
23 traveled may be controlled by the passenger and the fare is calculated on the basis of any combi-
24 nation of initial fee, distance traveled and waiting time if the vehicle:

25 (a) Is a passenger vehicle with a passenger seating capacity that does not exceed eight;

26 (b) Carries passengers for hire between points in Oregon; and

27 (c) Operates on an irregular route basis.

28 (18) Fire trucks and rescue vehicles that are designated as emergency vehicles by the Depart-
29 ment of Transportation under ORS 801.260, while involved in emergency and related operations.

30 (19) A person who provides services related to the packing or loading of household goods if the
31 person does not:

32 (a) Provide or operate a motor vehicle for the movement of the household goods; and

33 (b) Act as an agent for any person who does provide or operate a motor vehicle for the move-
34 ment of the household goods.

35 **SECTION 176.** Section 14, chapter 761, Oregon Laws 2007, as amended by section 94, chapter
36 762, Oregon Laws 2009, is amended to read:

37 **Sec. 14.** (1) There is established in the General Fund an account to be known as the University
38 of Oregon Integrative Science Complex, Phase 2 Account. Funds in the account shall be used for the
39 construction, remodeling, expansion and renovation of facilities for an Interactive Science Complex,
40 Phase 2 at the University of Oregon.

41 (2) The account shall consist of grant funds, gift funds, federal and local government funds made
42 available to and funds donated to the [*Oregon University System*] **University of Oregon** for the
43 purpose of the Interactive Science Complex, Phase 2 project described in subsection (1) of this sec-
44 tion. Interest earned on moneys in the account shall be credited to the account. The account may
45 not be credited with more than \$30,000,000 for purposes of this subsection.

1 (3) Moneys in the account shall be considered to be General Fund moneys for purposes of sec-
 2 tion 1 (3), Article XI-G of the Oregon Constitution, are continuously appropriated to the [*Oregon*
 3 *University System*] **University of Oregon** and may be transferred to the account designated by [*ORS*
 4 *351.626*] **the university** for the Interactive Science Complex, Phase 2 project described in subsection
 5 (1) of this section.

6 **SECTION 177.** Section 15, chapter 761, Oregon Laws 2007, as amended by section 95, chapter
 7 762, Oregon Laws 2009, is amended to read:

8 **Sec. 15.** (1) There is established in the General Fund an account to be known as the University
 9 of Oregon Hayward Field Account. Funds in the account shall be used for the construction, remodel-
 10 eling, expansion and renovation of Hayward Field at the University of Oregon.

11 (2) The account shall consist of funds received from not-for-profit organizations, grant funds, gift
 12 funds, federal and local government funds made available to and funds donated to the [*Oregon Uni-*
 13 *versity System*] **University of Oregon** for the purpose of the Hayward Field project described in
 14 subsection (1) of this section. Interest earned on moneys in the account shall be credited to the ac-
 15 count. The account may not be credited with more than \$2,500,000 for purposes of this subsection.

16 (3) Moneys in the account shall be considered to be General Fund moneys for purposes of sec-
 17 tion 1 (3), Article XI-G of the Oregon Constitution, are continuously appropriated to the [*Oregon*
 18 *University System*] **University of Oregon** and may be transferred to the account designated by [*ORS*
 19 *351.626*] **the university** for the Hayward Field project described in subsection (1) of this section.

20 **SECTION 178.** Section 24, chapter 904, Oregon Laws 2009, is amended to read:

21 **Sec. 24.** (1) There is established in the General Fund an account to be known as the University
 22 of Oregon Allen Hall Expansion and Remodel Project Account. Funds in the account shall be used
 23 for the construction, remodeling, expansion and renovation of facilities for a facility project at the
 24 University of Oregon.

25 (2) The account shall consist of proceeds from grant funds and gift funds made available to and
 26 funds donated to the [*Oregon University System*] **University of Oregon** for the purpose of the fa-
 27 cility project described in subsection (1) of this section. Interest earned on moneys in the account
 28 shall be credited to the account. The account may not be credited with more than \$7,500,000 for
 29 purposes of this subsection.

30 (3) Moneys in the account shall be considered to be General Fund moneys for purposes of sec-
 31 tion 1 (3), Article XI-G of the Oregon Constitution, are continuously appropriated to the [*Oregon*
 32 *University System*] **University of Oregon** and may be transferred to the [*Department of Higher Ed-*
 33 *ucation Capital Construction Fund*] **university** for the facility project described in subsection (1) of
 34 this section.

35 **SECTION 179.** **ORS 352.035 is repealed.**

36 **SECTION 180.** **Sections 1 to 4 and 7 to 64 of this 2011 Act, the amendments to statutes**
 37 **by sections 65 to 178 of this 2011 Act and the repeal of ORS 352.035 by section 179 of this 2011**
 38 **Act become operative on January 1, 2012.**

39 **SECTION 181.** **ORS 351.517, 351.518, 351.519, 351.521, 351.538, 351.539, 352.043, 352.045,**
 40 **352.046, 352.048, 352.049, 352.051, 352.052 and 352.053 are added to and made a part of sections**
 41 **1 to 52 of this 2011 Act.**

42 **SECTION 182.** **This 2011 Act being necessary for the immediate preservation of the public**
 43 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
 44 **July 1, 2011.**
